

Procedural Arrangements

The following procedures will be used by the President and Vice Presidents during the National Conference 27th September – 1st October 1999.

- 1 **Agenda** as set out in the Conference Programme will be adhered to unless the meeting determines otherwise.

Any business not included in the Agenda must be presented in writing to the National Executive no later than 9.00pm Monday 27th September for consideration and presented for debate if and when it is considered appropriate.

The President shall determine when introduced business genuinely arises from the current debate, and if so determined, it may become part of the Conference Agenda regardless of the date introduced.
- 2 **Resolutions** must be presented in writing and signed by the mover and seconder, together with a preamble and/or rationale.
- 3 **Recommendations and/or Suggestions** from Units, should they become Motions, must be presented in writing as indicated above.
- 4 **Reference Committee** of three (3) shall be appointed by Conference.
- 5 **Scrutineers.** Two (2) shall be appointed by Conference.
- 6 **Members wishing to speak** shall stand and wait until recognised by the President. Members shall address the President when speaking. All members are to please state their name and Unit or Organisation represented, before beginning to speak. Observers shall have the right to speak but not to vote.
- 7 **All Conference Papers to be taken as read**, but the presenter of the business may care to highlight certain aspects within limits as prescribed in Item 15.
- 8 **A Motion may be moved**, and the mover shall speak to the motion. Any motion which is not seconded shall lapse and not be recorded in the Conference Minutes.

The seconder of the motion may speak to the motion, or may reserve the right to speak later. (See Item 11)
- 9 **Motions may be debated** once they have been moved and seconded. The President may enquire if there is anyone wishing to speak for or against the motion, and may choose to alternate such speakers. If there are no speakers against the motion, the President shall put the motion to the vote.

The mover of the motion has the right of reply to the debate immediately prior to the vote being taken.
- 10 **Debating** Up to three (3) minutes will be allowed to each speaker unless permission is granted for an extension of time (for a maximum of two [2] minutes and must be moved, seconded and agreed upon).

No member may speak more than once on the same motion or amendment, except the mover, who shall have the right of reply. If debate exceed twenty five (25) minutes on one motion, it will be deferred to a later Business Session.

- 11 **Amendments** may arise from the debate, but the mover of the amendment shall not have spoken to the original motion. The proposed amendment must vary the subject matter of the motion, whilst maintaining the intent of the original motion. Any amendment not seconded must lapse and not be recorded in the Conference Minutes.

The President may choose to enquire if any amendment is likely to be seconded, before allowing the mover of the proposed amendment to speak to the amendment.

The mover of the amendment may not reserve the right to speak later.

One (1) amendment shall be dealt with at a time, with speakers limited to addressing the amendment subject. A speaker may foreshadow their intention (but not to speak to their proposal) to offer an alternate amendment following the resolution of the current amendment.

Any amendment must be taken in sequence.

- 12 **The debate is closed** when the time limit of twenty five (25) minutes is exceeded on the one motion; the President indicates she believes there has been sufficient debate; there are no more speakers; or when someone, who has not taken part in the debate, moves the motion "That the vote be now taken" and this is seconded and passed. The vote must be taken immediately without the mover's right of reply being granted.

If there is a motion and an amendment before the Conference, the amendment is put first to the vote. With the resolving of an amendment, the debate on the motion, or the amended motion, is resumed. Any foreshadowed amendment is now proposed and the debate resumed.

The mover of the motion may use their right of reply, after which the President shall put the motion to the vote. A simple majority vote is necessary for the motion to be carried. The President shall declare the result of each vote.

- 13 **Voting Entitlements** are:
2 from each State/Territory Unit
1 from each Denominational Organisation
5 from Incoming National Executive
1 from Winifred Kiek Scholarship Trust
All National Executive members.

- 14 **Voting Method** shall be by the Delegates displaying their official Voting Card when the vote is called for, unless otherwise decided by vote at the Conference.

- 15 **At all Reporting Sessions**, it shall be moved "That all reports be taken as read". Speakers to the National Executive and Unit Reports are allocated five (5) minutes, National Denominational Groups, Special Interest Groups, Winifred Kiek Scholarship Trust and National Representatives are allocated three (3) minutes. Questions and comments are not included in the time allocation, but at the discretion of the President.

PRESIDENT'S REPORT

During my term as National President I have found the position to be not only busy but very rewarding. My own horizons have been widened spiritually as well as geographically.

In March 1998 I was able to attend the seminar on Domestic Violence where suggestions were received for additions and alterations to be made to the working papers.

The Girls' Brigade International Conference in Brisbane on 8th July, 1998 was a morning to remember. Fifty-two countries were represented.

On 9th July the Prime Minister, Mr John Howard, visited Brisbane 'to meet the people'. I was pleased to accept an invitation to attend a function at the Wynnum RSL hall at which he was present.

The Round Table Conference arranged by the Office of the Status of Women was held in August last year in Canberra and which I was able to represent ACW. A bonus of the trip was a visit to the A.C.T. Unit on the day following the conference. I appreciated the opportunity to meet so many members of the Unit over lunch at the home of Mrs Evonne Sullivan after a morning of sight-seeing. An invitation to attend this year's conference has been received.

Using up frequent flyer points it became possible to visit Units and Branches around the country during October and November. My husband, Allan, and I also enjoyed the gracious hospitality of members in Darwin, Alice Springs, Perth, Adelaide, Launceston, and Melbourne which we much appreciated. Whilst in Perth I had the pleasure of speaking at the Community Day Service in the Salvation Army Citadel.

Both in 1998 at St. Stephen's Cathedral and 1999 at Ann Street Church of Christ I represented ACW at the World Day of Prayer services.

At the UNIFEM Breakfast in Brisbane on 8th march this year over a thousand persons attended. The inclusion of many young people from Brisbane schools in the programme demonstrated an awareness across the generation of women's issues, and especially the problems facing underprivileged peoples throughout the world.

My thanks to the NSW Unit for their invitation on 17 May, to speak at their Dedication Service. It was a rewarding experience. (My apologies for not being able to attend their 60th birthday celebrations.

Thanks also to those members who represented ACW at other functions. Heather Reid attended the Superannuation Conference in Sydney; Pat Franklyn attended the NCW meeting to investigate the possibility of a Millennium Conference; Margaret Florence represented ACW at the NCCA 3rd Forum in Sydney and Evonne Sullivan was present at the Prayer Breakfast at Parliament House, Canberra.

To the National Executive and ACWC representative I would extend my thanks for their dedication, hard work and loyalty. For many it has been a difficult time with personal health problems as well as illness of family members.

Thank you for the privilege of representing you. May God bless you all every day and in every way.

National Secretary's Report

The National Executive met each month during their two year term. We have met at the Catholic Women's League Rooms, within the Catholic Centre, Edward Street, City. This has proved very convenient as National Executive members have travelled from all areas of Brisbane to attend meetings. The monthly meetings have covered all facets of ACW and Conference planning and have lasted for up to five hours. Each Executive member has led in Devotions, which has been of great support and encouragement to us all. A time of fellowship has been experienced as we shared in Morning Tea, provided by members and lunch, purchased at the CWL Coffee Lounge. National Executive would like to thank the CWL Brisbane Diocese for the use of their rooms.

Minutes have been prepared and posted as soon as possible after the National Executive meetings. To keep State/Territory Units informed of all decisions and action taken by National Executive a covering letter has also been included. I would like to record my thanks to our Minute Secretary, Averil Jell for the accurate and efficient way she has prepared the minutes each month.

The National Executive has operated a Post Office Box for all mail. Mail has been collected and redirected to the President and Convenors as soon as possible so that any urgent matters could be dealt with. I have found the Post Office Box to be an advantage in the preparation of the Agenda and Correspondence for the monthly meetings.

We were not able to appoint a Social Justice Issues Convenor or Publicity Officer for our term of office. The National President has attended Seminars/Workshops on behalf of ACW, and members from State/Territory Units have represented ACW at Seminars/Workshops held in their State/Territory. We have endeavoured to respond to the many different publications and notices that have been received from Government Departments and Agencies.

The National Executive as requested by the National Conference 1997 prepared a Submission on the 'Rights of the Child' and sent the submission to the Joint Standing Committee on Treaties. In response we received from the Joint Standing Committee a copy of United Nations Convention of the Rights of the Child, Executive Summary - 17th Report. We were able to send a copy of the report to State/Territory Units. We thank the office of Senator John Woodley for photocopying the report for us.

I was privileged to represent Australian Church Women, as an Observer, at the 3rd Forum - National Council of Churches in Australia - October 1998. This was a very inspiring and stimulating time, and I thank the National Executive for this privilege.

ACWC Rep. Lynette Green was able to meet with the National Executive in August 1998 and discuss matters relating to the Asian Church Women Assembly, to be held in Chiang Mai, Thailand, and we thank Lynette for all the work involved in the preparation for this Assembly. In April 1999 Barbara Lacy, our present ACWC Rep., was able to attend our Executive Meeting and share with us some of the happenings from the ACWC Assembly. We thank Barbara for travelling to Brisbane to attend our meeting.

It was with regret that the National Executive received the resignation of Elizabeth Appleby from the Darwin Branch, and Joan McDonald from the Alice Springs Branch in June 1999. Elizabeth's husband has received a new appointment in Brisbane and they have now settled there. Joan and her husband have moved to Adelaide and have now settled there. We thank Elizabeth and Joan for their leadership in these branches.

I would like to thank the State/Territory Units, especially Unit Secretaries, for their help and support during the last two years. I have made many new friends during this time and look forward to meeting many of them at the National Conference. On behalf of the National Executive I would extend to the incoming National Executive our very best wishes and ensure them that -

"With God all things are possible".

Treasurers Report

I have pleasure in presenting the Treasurer's Report for the 2 years ending June 30th, 1999.

Offerings received at Fellowship Day Services and World Community Day Services have remained almost constant over the past 4 years. The money from Fellowship Day goes to the Winifred Kiek Scholarship Fund. Half of World Community Day offering goes to Asian Church Women Conference and the other half to the special project of the year. 1997 project was Bimbadeen Bible College at Cootamundra \$4510, 1998 project was Korea Church Women United Migrant Women Workers \$4637.

Fellowship of the Least Coin donations were fairly stable. 1997- \$33963.78; 1998-33827.90. Money was sent overseas by Bank Draft (cost \$15.00) or by International Money Transfer (cost \$25.00). In either case waiting for affirmation of its arrival at its correct destination is always a trying time. Patience helps.

Early in the 2 years, application was made for tax exemption from State Revenue Dept. following the lines taken by the previous treasurer. Our organisation was classed as an "umbrella group" for a member of religious institutions. The answer was "No Exemption" from Qld. State Government Tax.

Milise, WKS Scholar, did her study in Melbourne and travelled to Sydney, Canberra and Brisbane for a visit at a cost of \$612.00, and paid by WKS Trust. Lynette Green, Asian Church Women Conference Representative, met with National Executive to discuss plans for the conference to be held in Chiang Mai, Thailand. A Total of \$1166.00 was paid for 3 delegates to attend. Money from work stall was given to the Asian Conference. Special thanks to Lynette for a job well done and best wishes to Barbara Lacy as she starts her 4 years as Australia's representative.

As there is no subscription from Units to National Executive the working capital comes from money transferred from Fellowship Day, World Community Day and FLC donations. At 1997 Conference it was moved that up to 10% be taken for administration costs from offerings. I chose to keep it at 5%, but I realise that increase is necessary. The new Executive should take at least 7 1/2 % 1st year and 10% in the year of conference.

I would like to express my appreciation to Helen Lloyd for lots of advice in the early days and to Chris Walsh – our Auditor.

My prayers and best wishes are with the incoming National Executive from south Australia as they carry on this work for the next 2 years.

THE 11TH ASSEMBLY: The Assembly statement is attached. Australia moved the motion that we revive the Prayer Partnership among ACWC member Countries. Australia's prayer partner is **PAKISTAN** and we are in contact with their National representative, Ms Shunila Ruth. We are encouraged to pray for the women and people of Pakistan at our meetings and services.

WE ACKNOWLEDGE THE PRESENCE, ACTIVE PARTICIPATION AND RICH INSIGHTS of our former ACWC leaders, international guests, observers and the local women's committee.

WE CELEBRATED THE LIFE OF SHANTI SOLOMON and her contributions.

WE WERE ENRICHED by the fellowship and sisterhood and rejoiced through worship, weaving together and solidarity night.

WE BECAME AWARE of the painful condition and struggle being experienced by our Asian sisters as well as women around the world through violence against women, injustice, victimization and other issues affecting them.

WE AFFIRM the need to build a community of God's people, and to reclaim our rich spiritual heritage.

WE RECLAIM OUR SPACE as equal partners in the family, church and society, and recognize the different gifts and talents of women as given by God.

WE AFFIRM that ACWC is committed to respond by taking action of work for mercy and justice, peace and reconciliation by means of education at all levels and strengthen the networking, seeking for prayer partners among Asian women.

WITH THE HELP OF THE HOLY SPIRIT, THE PARTICIPANTS WERE CHALLENGED TO MOVE FORWARD INTO THEIR COMMUNITY WITH DEEPER COMMITMENT AND HOPE.

WINIFRED KIEK SCHOLARSHIP REPORT

SCHOLARSHIP

The 1997 Scholar, Captain Joanne Harries, completed her course in New Testament Studies during 1998. This had been delayed twice due to the availability of the course, and later whilst recovering from the premature birth of her twins.

The 1998 Scholar, Melisa Taipaleti from Tonga, had a very successful year undertaking a pre-entry course for her Masters in Theology at the Melbourne College of Divinity. Before returning to Tonga for Christmas, Melise was able to visit the New South Wales, Australian Capital Territory, and Queensland Units. The Trustees were delighted to agree to assist with help from the Fellowship A/c, and these visits were apparently a great success. We wish Melise well with her continuing study and assure her of our prayers.

Our 1999 Scholar, Mai Zin Zin Wah from Myanmar has now commenced her studies for pre-entry Masters Degree at the Trinity Theological College in Singapore. I must say that we were pleased when we finally had advice to transfer the funds to a bank account in Singapore in early July at the commencement of her studies. Although we had thoroughly investigated the possibility of any problems Mai would have in leaving her country, it was a joy to know that it was actually happening. We look forward to hearing from her in due course.

FELLOWSHIP

We are delighted to have with us at this Conference Ms Esther Byu, the Executive Secretary of International Committee of Fellowship of the Least Coin. The Trust is delighted to assist with her travel, and I am sure that we will all benefit from having met with her and hearing her presentation.

GENERAL

We have made further changes to the application form in the hope that it would reduce the number of queries that are often necessary. This is especially difficult when we receive applications from the South Pacific and Asian areas. We realise that the language can be a problem, but it is very difficult to finalise the selection of the scholar when sections of the forms are left blank. To this end we regretfully made a decision to state on page 2 of Form 1 that all questions in this section must be completed to enable the application to be considered. This may seem harsh, but it is difficult and expensive to make international phone calls, particularly if the person to whom you wish to speak is hard to find. As my husband is now retired I don't have easy access to a FAX machine, and although I was able to contact Myanmar once by Email, further contacts have only been made by phone, but with some delays. Australian applications are not always perfect, but it is not quite so difficult to obtain answers to queries, although as we all know Australia is a big country. I would like to mention that the sponsoring body should make every effort to ensure that the forms are fully completed and that the required references etc. are attached. If the ACW Units could possibly assist with this matter in any way we would be very grateful.

It would also be helpful if the end of year scholar's report is submitted to the Trustees. This is one of the points included in the Scholar's Agreement, but it is more the exception than the rule. It is always very interesting to hear from the scholar, and we are ever eager to learn of any improvements that we could make to the programme in general.

THANK YOU

The Trustees express their appreciation to Ailsa Skippen, WKS National Convenor, Aileen Mortensen, National President and Margaret Florence, National Secretary for their support and prayers over the past two years. Our thanks also go to all Units, especially the WKS State Convenors, who have so kindly and happily assisted Scholars with their travel arrangements etc. I am sure that it has been much appreciated by the recipients.

My personal thanks to the other Trustees for their continued loyal support, enthusiasm and friendship. Once again the assistance and expertise of our Treasurer, Jess Horton and our Scribe, Norma Bishop is almost invaluable. During my trip overseas last year Barbara Grealy happily and efficiently dealt with the application forms and other queries, for which I am very grateful. I continue to enjoy our time together – we make a great team.



TREASURER'S REPORT 1997 - 1999

Over the last two years the Capital has increased by \$12,000 in 1998 and \$12,400 in 1999. Which indicates a continued national commitment to this very worthwhile scholarship. This is vital as with interest rates remaining low, new capital is necessary. The 1999 recipient has received \$10,800 for study in Singapore. The amount available for year 2000 scholar is approximately \$1,700 less but as the recipient is from Australia this amount is adequate there being no expensive travel involved.

The Memorial Bursary funds available in 1998 were used by Milise Tapaleti and to date none of the 1999 money has been requested. During 1998 Milise Tapaleti was able to visit the Eastern states with funds made available from the Winifred Kiek Fellowship. NSW UNIT REPORT TO ACW NATIONAL CONFERENCE – SEPTEMBER 1999

The NSW Unit has had two wonderfully full and interesting years and we thank God for opportunities, challenges and blessings.

In May 1998 we celebrated sixty years with a Diamond Jubilee Thanksgiving Service and Luncheon. Our inspiring guest speaker was Commissioner Lorraine Buckingham of the Salvation Army Eastern Territorial Command.

We have given a high priority to activities relating to Aboriginal Australians, hearing speakers from the Council for Reconciliation (Elaine Telford), the Aboriginal Inland Mission - AIM (Cliff Letcher), and Bimbadeen College – Aboriginal Evangelical Fellowship (Beryl Burke). During her Presidency Peg Blake represented us at the Enquiry into Dedicated seats for Aboriginals in Parliament. Many of us were among 2000 in St. Mary's Cathedral for the churches apology to Aboriginal Australians organised by the NSW Ecumenical Council. We were delighted to assist two young Aboriginal women to broaden their ecumenical experience – Kayleen Manton (wife of a Presbyterian Aboriginal Pastor in western Sydney), who attended the Asian Church Women's Conference in Chang Mai; and Lisa Jackson (from the Aboriginal and Islander Commission of the National Council of Churches), who will attend the Central Committee meetings of the World Council of Churches in Geneva as a youth steward. She is the first Aboriginal Australian to be chosen for this honour. We have been represented at activities of Women for Wik, and are grateful for the Fellowship of the Least Coin grant offered to Crossroads Aboriginal Ministries.

The FLC grant to the Somali Refugee Program has also been most effective with more than 50 women participating in the sewing scheme.

We are delighted by the growth of interest, attendances and offerings at Special Days Services – Fellowship Day was held in 36 centres and World Community Day in 40 centres. We have formally welcomed into membership the Congregational Federation of NSW, the new Kincumber Branch of ACW, and Church Women of the Hunter (CWH).

Our annual Asian Church Womens Service continues to grow, with attendances of Korean, Chinese, Filipino, Cambodian and other Asians Christians worshipping with Anglo and Pacific Islanders.

A wide range of current social issues is brought to our attention for appropriate action and responses. This year our focus has been on the International Year of the Older Person. We have been ably represented on the Council for the Ageing's Coalition '99 by Heather Reid. Our Annual Ecumenical Luncheon was addressed by Mrs Marjory Deasey, a 4 times retired missionary, whose theme was 'You're never too old to be of use'.

Many useful recommendations, and much inspiration, came from our State Conference in May '98 with the theme 'Towards 2000 – Walking Together'. We plan another conference in 2000 and we are preparing to celebrate it as the Year of Jubilee.

Together with the National Council of Women we have supported Fiona Collins and Mia Hoggenboom in their OzIndo Project. This is a year-long, 16,000km, sponsored bicycle ride around Australia to raise funds for Indonesian women and their families.

We have been delighted and blessed by two visits from ACW National President Aileen Mortensen, and a visit from the '98 Winifred Kiek Scholar Milise Taipaliti.

We have continued to give testimony to our city by participating in the Cathedrals Spring Flower Festivals, and by maintaining our association with the National Council of Women, The NSW Ecumenical Council, the NSW Council for Children's Films and Television, The Women's Temperance Union, the Girl's Brigade, and the Pan Pacific and SE Asia Women's Association.

Life Membership (ACW NSW) has been conferred on Mabel Ward, Mina Whybourne and Edith Ridge. Congratulations were offered to Marie McCann, honoured in the Order of Australia and to Joan Tong, nominated for the NCW Woman of the Year Award, and for her re-election as President of the NSW Ecumenical Council. Colleen O'Sullivan, Margaret Collier and Lucelle King have been farwelled from the Executive and we have welcomed Eileen Holley, Irene Carder and Glenys Holley. We remember with sadness and thanksgiving former Executive members who have died –Doris Mitchell, Beth Finlay, Linda Perriam, Edna Baker, Leah Pickering, Mabel Ward, and Yvonne Davis.

We are delighted that our fabulous secretary, Jan Harrison, has been nominated by Archbishop Goodhew as our President Elect! With praise and thanks to God and all the wonderful people in ACW NSW for the achievements and blessings of the past two years:

SOUTH AUSTRALIAN UNIT

REPORT TO THE NATIONAL CONFERENCE OF AUSTRALIAN CHURCH WOMEN

GRACE COLLEGE SEPTEMBER 27TH – OCTOBER 1ST 1999

Unit and Business Meetings are held on the second Friday each month from February to November at the Pilgrim Centre, Flinders Street, Adelaide.

Membership has increased, slightly, with the addition of five Associate members. Five metropolitan and two country branches remain affiliated and work tirelessly, networking in their own areas to keep members in the work of ACW.

During 1997, Unit meetings provided opportunities to learn more about a variety of topics, such as the conference of the World Federation of Methodist and Uniting Church Women who met in Rio de Janeiro for their international gatherings.

We learnt of the dedicated work being done in support of refugees and migrants from Christine Loveday who has worked for many years, believing that God has chosen her to show His love to those people seeking re-settlement in countries other than their own.

An invitation was accepted for the Unit to be represented at the official opening of the new headquarters for the SA Council of Churches.

Mrs Jenny Main was guest speaker at the World Community Day service in October and told of her experiences, having spent 19 years service with the Salvation Army in India and 4 years in Romania working with World Vision.

The WKS in this year assisted two Australian women undertaking further studies. The SA based WKS Trustees selected a woman from Tonga as the 1998 recipient of the Scholarship.

Fellowship Day services were held in 6 metropolitan and 5 country centres with donations being received from several other fellowship groups.

Social Justice raises awareness of inequalities in life and the desire for things to be better. Athalie Ford, Social Justice convenor, brought to our attention the ongoing deliberation concerning Aboriginal Reconciliation. The traumatic experiences of women who find themselves serving gaol sentences and the impact that has on their lives. A watching brief was kept on the issues of anti-personnel land mines and on behalf of the Christian Blind Mission International, a petition was sent to the Commonwealth Government concerning the banning of laser weapons. Letters were sent to State and Federal Health Ministers expressing concern about rural health issues.

Trustees of the J150 Trust of South Australia were pleased to be able to present five awards to assist disadvantaged women. A report back is required to learn how the awards are used and to what benefit to the recipients.

Our Community Concern Morning Teas project reached out into a new area by supporting the Joint Churches Action Group on domestic violence. It was encouraging to see some younger women attending these functions.

1998 was a very busy year with the Unit grasping opportunities to listen, learn and to express its concern for the welfare of the disadvantaged and often neglected people in the community, for example; services to the frail and elderly, health and care services, the ongoing struggle to secure Native Title and Reconciliation, the campaign to ban Land Mines, the social implications for the mentally ill in community based care, poker machines and the impact they are having on family finances and support services to assist victims of crime. Our members are aware that as Christians we need to be concerned and prayerfully vigilant.

Speakers invited to address members at Unit meetings have been excellent in addressing their chosen topic. Mrs Barbara Agacy spoke about the work being done to help victims of crime by the Victims of Crime Support Services in south Australia. Ms Anne Van Loon told of the service provided by the Faith Community Nurses Association and Dr. Brian Nelder spoke enthusiastically about his work with the Lutheran Church in Europe and Africa.

Margaret Greenslade, Convenor of the Fellowship of the Least Coin, spoke to eleven groups during the year about the history of the foundation of F.L.C. in 1956. World Community Day Services were held in each centre, everyone appreciating the theme of "Unity in Diversity" prepared by the Tasmania Unit.

Maureen Clark, Convenor of the Winifred Kiek Scholarship, reported that seven centres held Fellowship Day Services in the metropolitan area and seven in country areas. A new centre was formed at the Seaford Ecumenical Mission, Seaford.

A Celebration Service was held in May for the end of the "Churches in Solidarity with Women Decade". Many denominations were represented and heard of the contribution made by women in the Church from biblical times, through the decades to the present times.

The Community Concern project for 1998 was the Childhood Cancer Support Association, a support group made up of parents and friends of children suffering from cancer. \$3,284 was raised over a period covering May to August when fifteen Morning Teas were held at venues in the Metropolitan and near country areas. Extra donations of money and food items were generously given by women attending the Morning Teas to support the Family Support Units which is a base house for parents to stay while they visit the hospital during a child's treatment time which may take an extended time.

The Jubilee 150 Trust, which was established by the late Pauline Crosby to help disadvantaged women, made two Awards for 1997-98 to the value of \$650. Reports from the two sponsoring bodies indicated the monies allocated were of considerable assistance to the recipients.

Lyn Smith, Social Justice Convenor, brought to our attention the following concerns:
Landmines: Advice was received from an international source, that the International Campaign to ban Landmines Organisation will continue to focus on the three major areas of concern, and through working groups, will provide assistance to victims – help to clear mines and lend support to the legal and moral responsibility of this issue. Regular feedback is being received.

Model Domestic Violence Laws: A recent review of the legislation reveals little consistency between the States and Territories which has led to a further review of existing laws to see what can be gained from a national perspective rather than trying to develop something new.

Model Criminal Code – Slavery and Sexual Servitude Offences: A discussion paper was received outlining proposals for reforming the laws to deal with offences on "Non Fatal Offences Against the Person". The present structure of offences is confusing because of the

considerable overlap which exists between a number of offences. Following receipt of submission, a final report is awaited

1999:

Mr Chris Keating, Executive Officer for the Diocesan Commission for Justice and Peace, spoke at the March Unit meeting about the Jubilee 2000 Debt Coalition Charter, presenting a most informative overview of the implications involved in bringing about acceptance of the Charter. Petition Forms for the collection of signatures were available.

Cross Cultural Ministry was the topic for the May Unit Meeting. Mr Scott Litchfield, Consultant for the Uniting Church on World and Cross Cultural Ministries, spoke about the need to support churches using languages other than English in their Church Services, the need to raise awareness about refugees and their needs and to encourage the Church to look outside itself towards local and global relationships with ethnic communities.

Across Our Church Communities was the theme for the July Unit meeting. With a change of format from the usual agenda, small groups were formed and a representative from each denomination spoke for five minutes on the findings of her denominational group who had previously discussed where they saw the Church, today, and their visions for how the Church can be effective into the 21st Century. The topic was the outcome of an address presented at the Annual General Meeting held in November, 1998 by Rev Cathy Thomson. Cathy challenged us to also consider how we, as an ecumenical body within Australian Church Women, plan to reach out into the community and interest women in the work of the Church in the new millennium. Scribes reported back on the findings of questions asked of the small groups and the whole exercise was summarised by Cathy Thomson. A most rewarding time of discussion and fellowship which members appreciated.

This year's Community Concern Project has been the Cystic Fibrosis Association. Fifteen Morning Teas with trading tables have been arranged to support the project. The Association's Publicity Officer has given information about Cystic Fibrosis and has told of his own experiences as a sufferer, for which there is no cure. Proceeds received from these occasions will help support research into the disease. A cheque will be presented to the Association at the Annual General Meeting in November.

Affiliation with other organisations is an expression of our outreach which we feel to be important in reaching and networking with the wider community. Representatives attend on our behalf; The Bible Society in South Australia, the National Council of Women of South Australia Inc., Lavender Lads and Ladies Auxiliary, World Day of Prayer South Australian Committee, and the United Nations Association, South Australian Division, Status of Women.

VALE: We record, with sadness, the sudden death of our esteemed member and Secretary, Mrs Lois Harris, in September 1998. Her untiring energy, cheerful presence and her capacity to do all things well, was an inspiration to us and one we will hold dear into the future. We are deeply grateful for the commitment Lois made to the life of our Unit as Secretary and friend. We praise God for the privilege of sharing in her life journey.

MU Australia Report for the ACW National Conference – September 1999

MU Australia is on a special journey. A journey we believe will lead and equip us for our work in the new millennium. We have spent much time in praying and worshipping together, discussing, debating and consulting as we have prepared ourselves for the exciting times that lie ahead for us in ministry.

Our members hold fast to the vision of our founder, Mary Sumner, “**to win the homes of the nations of Christ**”, and we have developed our new mission statement “**Sharing Christ’s love by encouraging, strengthening, and supporting marriage and family life**”, to guide us in pursuing that vision. We see the great opportunities God is giving us and we want to be intentional, contemporary, and flexible as we minister in our time and context. To express both our Australian identity and our changing structure we prefer now to be known as **MU Australia – part of the World-Wide Mothers Union.**

To celebrate being part of our world wide organisation, the Presidents from all the 23 Australian Dioceses were able to go to UK in July 1998, to attend the World Wide Council of MU, which is held every ten years. Delegates numbered over 400, and included members from every continent. This was a very encouraging time of fellowship, worship and work as the future of MU around the world was discussed, with the thrust of evangelism and outreach being central to our ministry.

In September 1998, our triennial elections were held, and a new Australian President, Jan Livingstone from Sydney and a new Executive Committee were elected. A new department of Promotion and Development under the leadership of Rev Wendy Pullin has been set in place to promote the Christian faith and the work of MU. The Journey in Faith we have embarked on is full of promise and challenge as we continue in prayerfulness on our way.

A great source of pleasure and pride has been the recent award received by our Immediate Past President Elizabeth Appleby. Elizabeth’s work has been recognised in the 1999 Queen’s Birthday Honours List. She became a member of the Order of Australia in The General Division for service to women’s affairs through The Mother’s Union, and to the community, particularly through The Red Cross.

Our social responsibility Department was requested to send a submission to the senate select Committee, on problems associated with easy access for children to unsuitable material on the internet, and is currently working on another submission about online gambling. REPORT OF PRESBYTERIAN WOMENS ASSOCIATION OF AUSTRALIA FOR 1999 CONFERENCE OF AUSTRALIAN CHURCH WOMEN.

The Presbyterian Women's Association of Australia have State Units, which have their own Committees to carry out our Christian Commitment to society. These encourage those on the fringe of the Churches by planning and organising their meetings sometimes on 'neutral' grounds, inviting friends, relatives and workmates to social functions such as luncheons at restaurants barbecues at a park etc. as well as regular type meetings and money raising functions. Bible Study Groups and State Camps and Retreats have proved stimulating, sharing the Love of the Lord. The Main Avenues of service are:-

1. **MISSIONARY** - where we support our missionaries in many countries of the world, financially, with gifts, and prayers. The N.S.W. P.W.M.U. Standing Committee have issued a booklet this year "Adopt a Missionary" which has been given to their Branches to encourage support for Missionaries and to give ideas and guidance. State Missionary Rallies give us chances to hear Missionaries when they are on furlough.

2. **CHRISTIAN EDUCATION** :- Design and print leaflets for sale to Church Groups. They also prepare Study material and conduct Study and Fellowship Days. Leaflets prepared as follow-up to infant baptism and contain encouragement for parents and a list of suitable books for children.

3. **HOME MISSION & CHURCH EXTENSION** In excess of \$17,000 was raised to purchase High Frequency Radios to enable part time P.L.M. Padres in N.S.W. to contact their home base as well as folk along the way.

4. **DORCAS** this year is celebrating "The International Year of the older Persons" with an appeal to support Aged Care within the Church. Many interesting functions have been organised by branches to honour the contribution that has been made by older persons in their communities.

5. **THE MARKET COMMITTEE** in Sydney has supported Aged Care:- Westcott at Stockton and Historical Records and Library Committee.

6. **CARE AND CONCERN** cares for visiting hospitals, 'shut ins' contacting new families, giving aid to needy folk wherever needed to alleviate suffering. In recent years, the Lord has challenged us to a greater commitment to carry the Word of God to all those in need of a Saviour.

7. **OUTREACH** . Three of our members have just returned from Suva, Fiji, where Presbyterian Women met for their second Conference. to establish a networking group among women from the Presbyterian Churches of Asia, Pacific Nations and Southern Africa. They were inspired by the fellowship and wonderful speakers. We are planning to Celebrate the year 2000 with a Special Christian Witness week between palm Sunday and Easter.

It has been my pleasure to give this report and hope and pray that we can continue with our Christian Witness serving the women within our Churches as we enter into the new Millennium.

THE SALVATION ARMY – AUSTRALIAN EASTERN TERRITORY

Ministry to Women and Families continue to be a strong component of the Salvation Army's expression of service to congregation and community. The women's programs are based upon a 4/fold foundation offering opportunity for Worship, Education, Fellowship and Service. All programs are designed to develop these.

Along with offering opportunities to participate in worship and develop spiritually, groups focus on specifics recognising local need. Developing programs available include,

Worship – Christianity Explained – Bible studies – Prayer groups – “Growing in faith” discipling groups.

Fellowship – Coffee Mornings – Ladies Nights Out – Women's Special Interest Groups i.e. craft classes, health and fitness, self esteem awareness groups – line dancing,

Education – Life skills development – Budget advice – Parenting skills – training in care for the housebound and families of prison inmates as well as hospital visitation, nursing home services and care for the elderly in their own homes.

Service – Overseas Ministry support – sponsorship for children in developing countries – support for training programs in developing countries – fundraising for the local congregation and work amongst the young people.

Pre-school groups for mothers and children are growing rapidly. Mothers attend with their toddlers and respond positively to the friendship and support offered over coffee while their children 'have fun in a safe environment'.

Decisions for Christ are being registered and women and their families introduced to the warm fellowship of Church life.

Highlights of the year's activities include a residential Bible Convention for Women. Registrations reached 700 and attendance brought together women of all ages from late teens through to senior citizens. The topic “Journey in Grace” captured the imagination and the hearts of all who attended and many testify to a life changing experience as a result of this occasion. Our International Leader – Commissioner Kay Rader was the guest speaker and a similar event is held for the men and is also warmly received.

Camps are another special occasion for ladies to enjoy each other's company, examine their spiritual development and explore new ways of serving the community and reaching others for Jesus. This year a number of special events have been planned to recognise the Year of the Older Person.

“People Count” and “Deeds of Kindness” are two motivating concepts which have led to some real growth in Friendship Evangelism. The Women's Program offers a ready made platform for developing these themes.

A training tour through our Territory focused on motivational leadership. Our guest from the United States of America developed the theme of servant Leadership – “You can impress people from a distance but can impact people if close up”. “God does not always call the equipped but promises to equip the called” brought both challenge and encouragement to leaders.

A sense of mission and a real desire to reach others with the Gospel is evident and we are excited about the innovative ways women are developing to care for the household of faith and serve the community in the name of Jesus.

Uniting Church in Australia Adult Fellowship National Committee

REPORT TO AUSTRALIAN CHURCH WOMEN NATIONAL CONFERENCE

27 September - 1 October 1999 at Brisbane.

The National Committee of the Uniting Church Adult Fellowship is a co-ordinating body. Responsibility for forming this Committee moves from Synod to Synod each three years. The present Committee, based in Western Australia, is now in its third year and has fulfilled many of its responsibilities, including

- *representing the Uniting Church in Australia at the two National Conferences of Australian Church Women
- *planning organising and 'hosting' the UCAF National Conference held each three years. This Conference is not for business matters but is intended to be a time of inspiration and spiritual growth open to all UCA adults. The 1998 Conference was held at a Conference Centre in a Perth suburb and attended by approximately 130 women and men from all States who enjoyed the opportunities for fellowship and the program which included a speaker and bible study on the theme 'Signposts for our Journey' plus opportunities for elective studies and outings.
- *sending two delegates officially representing the UCA at the second Consultation of Bridgebuilders International, a new organisation of Presbyterian and associated women based in the Pacific area, held in Fiji in July.
- *having ²⁶ ~~sixteen~~ members attending the World Federation of Methodist and Uniting Church Women's South Pacific Area Seminar in Samoa in August.
- *intentionally widening our participation in the life of the church nationally by
 - .sending a representative to each annual meeting of the Gospel and Gender Committee of the Assembly
 - .sending a representative to each annual consultation of the Assembly agencies.

As National President I went on a tour to each Synod (in the 6 States and NT) where I met with Synod Committees and spoke at rallies, dinners, lunches, meetings and informal gatherings in cities and in many country areas. This tour, funded by the Synod Committees, allowed me to report on our stewardship as a National Committee, and to meet with and address women and men who belong to the Adult Fellowship groups in churches across the land.

'Adult Fellowship' begins at local church level where it has its base; it is then experienced by many at Presbytery level where rallies, coach outings, gatherings, meals etc are shared and bring people into a larger community than is the usual in small churches. Occasional activities are planned at Synod level, including support for the 'service' arm of our Adult Fellowships where the emphasis is on mission and outreach, and funds are raised. 'Fellowship' and 'service' go hand in hand within the life of Adult Fellowship groups in the UCA in local churches and at presbytery and synod level - and this National Committee continues to do the particular tasks allotted to it, the last of which is to plan and resource the Consultation, the triennial business meeting of UCAF, in May next year. We will then hand over our responsibility to a new National Committee to be formed in Victoria.

National Churches of Churches in Australia

It is now over five years since the Australian Council of Churches was transformed into the more comprehensive National Council of Churches.

The ecumenical family there represented continues to grow. The Lutheran Church in Australia joined in 1998, so the council now comprises seven Orthodox churches, five Protestant churches, the Anglican Church and the Roman Catholic Church. The Baptist Union of Australia and the Congregational Federation of Australia have become observers, along with the Presbyterian Church and the Seventh-Day Adventists.

Major Programme initiatives in this period include –

- Movement towards a multi-dimensional covenant between the churches. This would be based on inter-church agreements including one or more of the following: decision-making with consultation; common strategies for mission; common witness; shared use of buildings; and shared ordained ministries.
- The Pilgrimage to the Heart – a journey planned for the Week of Prayer for Christian Unity, in June 2000, that will take heads of churches plus a young person from each church from Canberra, through isolated inland communities, to celebrate Pentecost together at Uluru.
- Standing against racism and supporting Australia's indigenous peoples, with the strong leadership of the NCCA's Aboriginal and Islander Commission.
- Finding more ways for the churches to work together, in practice, through Christian World Service. Last year's Christmas Bowl Appeal was up, not enough but at least the movement is in the right direction.
- A gathering of youth leaders from member churches to work at the future of youth ministry in Australia.
- Major statements on Unemployment and Housing in Australia.
- In coming months the NCCA will host a major conference of Asian theologians and social scientists in Darwin, to reflect on "Church and Society" issues facing the churches of our region. Also, the Council's faith and Unity Commission is arranging an assessment of how bilateral talks between the churches are going, in Melbourne on October 25th.

The NCCA's Network on Women and Gender Relationships continues to evolve, clarifying its role and facilitating deeper understanding by the churches of each other's traditions and the issues they severally are facing. A major gathering, "Celebrate Women – Celebrate Church" brought together over a hundred people for a day before the 1998 NCCA National Forum. Work is preceding to collate and publish information about women's groups associated with the churches.

Through these and other initiatives, the churches continue to press forward towards the vision of a transformed church that is visibly one in its obedience to the risen Lord.

Greetings from The Girls' Brigade Australia

We have been busy over the last two years.

The Girls' Brigade Constitution. Our new Constitution was lodged and passed last year. Now all of our States have lodged their own Constitution and have become Incorporated.

International Conference of The Girls' Brigade (I.C.G.B.). Last July, 1998 saw the Girls' Brigade Australia hosting a very successful International Conference in Brisbane. The holding of such an event was a wonderful experience, meeting with about 240 people from 35 countries. The Christian atmosphere was electric when the many different cultures came together to worship the Lord. In between meetings, devotions, worship sessions, work shops and decision making times, there was trip to Brisbane and the Sunshine Coast.

We have changed our world structure from 2 to 5 regions, now known as Fellowships. They are European Americans and Caribbean, African, Asian and the Pacific. Each Fellowship has an elected Chairperson, also known as an International Vice president. At the I.C.G.B. a new International President, Mrs Jill Clarke, from New Zealand, was elected for the next four years. Thailand will be hosting the next I.C.G.B. IN 2002.

International Fonomarae. A Fonomarae is a camp for older girls (Pioneers) and Young Leaders. Fonomarae is a combination of FONONO – a Samoan word meaning "getting together" or "meeting" and MARAE – A Maori word meaning "meeting place". Every two years in Australia a National Fonomarae is held, the next one in Western Australia in 2000. It was decided to hold an International Fonomarae to run in conjunction with the I.C.G.B.. There was over 200 girls and Leaders in attendance and it was held in Queensland (run by our New South Wales Leaders). There was many friendships formed from this event. Devotions, worship time, culture activities, outings and workshops were included in the main part of the program.

Leader's Training. Our Leader's Training has been rewritten to bring it in line with our new Leader's Handbook that was accepted at our last National conference in Perth, October 1997.

National Conference. South Australia will be hosting the next National Conference in July 2000 at Immanuel College, Novar Gardens.

THE GIRLS' BRIGADE AIM:- "To help girls to become followers of the Lord Jesus Christ and through self-control, reverence and a sense of responsibility to find true enrichment of life".

THE GIRLS' BRIGADE MOTTO:- SEEK SERVE FOLLOW CHRIST.
This motto is illustrated on the badges that our Juniors (girls aged 8 to 12 years) can earn.

Thank you for the opportunity of sharing with you a few of the exciting things which have been happening in World Day of Prayer during the past two years.

In November 1997, the National Quadrennial Conference was held in Adelaide with representatives from all states attending. We also were privileged to have Taumua Toma and Yvonne Harrison with us on this occasion. They were our Pacific representatives to the International Committee at that time. At the conclusion of the conference, Barbara Grealy finished her term as National Liaison Officer and Noelene Roose was inducted into this position.

The service for 1998 was written by the Christian women of Madagascar and was entitled "Who is my Neighbour?" This was very well received. This year, 1999, the service was written by the W.D.P. Committee of Venezuela and was called "God's Tender Touch" and the reports have been very positive. We look forward to the year 2000 when we will hear from Indonesia - "Talitha Kumi. Young Woman, Stand up!"

The highlight of this year has been the 9th Quadrennial Meeting of the International Committee of World Day of Prayer which was held in Cape Town in April. 199 women from 92 countries attended the meeting. The theme was "In Christ, Global Partners in Reconciliation." Delegations from Bulgaria, Croatia, Estonia, Macedonia and Bolivia attended for the first time. Many women gave witness of the demanding work of reconciliation in their countries. Dr. Mercy Amba Oduyoye led 3 Bible studies to deepen the theme. We attended an Ecumenical service in the city, an African Cultural Programme in City Hall and had a day out when we were able to visit Robben Island where Nelson Mandela was imprisoned for so many years. We were delighted when Yvonne Harrison, from Launceston, was elected President of W.D.P.I.C. for the next 4 years. This is the first time this position has been held by a member of the Pacific Region.

At the 1997 National Conference it was agreed that the position of Publicity Officer on National Executive be reactivated. (Motion 10)

GUIDELINES – PUBLICITY OFFICER

The National Publicity Officer shall:

1. Act on resolutions passed at National Conference relating to National Publicity of Australian Church Women.
2. Prepare monthly report (including correspondence in and out) for National Executive.
3. Maintain a file of all correspondence for duration of office and hand on to successor.
4. Compile a list of contact persons from each State/Territory Unit, each National organisation of denomination participating in Australian Church Women, each National special interest group participating in Australian Church Women through its State/Territory Unit.
5. Prepare information concerning the work of Australian Church Women to be Released to –
 - a. State/Territory Units
 - b. National organisations of each participating denomination, National special interest groups participating in Australian Church Women.
 - c. The General Press.
 - d. Such information to be ratified by the National Executive before release.

GUIDELINES – SOCIAL JUSTICE ISSUES

A committee may be appointed by National Executive to support National Social Justice Issues Convenor.

National Social issues convenor shall;

1. Convene committee (if any committee used)
2. Act on any resolutions passed at the National Conference relating to Social Justice Issues.
3. Prepare monthly reports (including date & details of correspondence in and out) for National Executive.
4. Maintain a file of all correspondence for duration of office and hand on to successor.
5. Compile a list of all State/Territory Units Social Justice Convenors. Encourage all Unit Convenors to promote Social Justice Issues by providing up-to-date material, and ask them to share information on issues, which could be helpful to others.
6. Inform all State/Territory Units of relevant Social Justice Issues and produce articles for Editor of ACW News.
7. Prepare a report (to be included in the Working Papers for National Conference) of approximately one (1) page A4 size. This report to be forwarded to the National Secretary two months prior to the date of the Conference.

In accordance with Recommendation 2 – National Conference 1997 – National Executive have prepared the following for discussion –

Recommendation 2 from NSW Unit.

Clarification is requested on the criteria for affiliation with ACW denominationally speaking, and by what method is an individual deemed eligible for affiliation. The ACW constitution gives no direction.

- 4. **Membership:** Each and every member of a State or Territory Unit shall be a member of Australian Church Women.

PROPOSED –

4. Membership:

- 4.1 Membership is open to women of those Churches and Christian Communities which accept the Aims of Australian Church Women.
- 4.2 Associate Membership is open to individual women who accept the Aims of Australian Church Women, are ~~credited~~ *active* members of their Church or Christian Community.
- 4.3 Life Members
 - 4.3.1 The honour of life membership

RATIONALE:

At the 1997 National Conference clarification was requested on the criteria for affiliation with ACW denominationally speaking, and by what method is an individual eligible for affiliation.

The National Executive sort legal opinion on this matter (which is attached). As a result of our discussion the above changes are proposed.

Australian Church Women

Membership Qualifications

Qualifications for membership of ACW. The specific question is whether professing Jehovah's Witnesses or Latter Day Saints are entitled to be members of Australian Church Women (ACW). This raises the more general question as to the beliefs or denominational adherence that a person must hold before being entitled to become a member of ACW.

In short, the national executive of ACW has no power to answer this question. The reason lies in the decentralised federal structure of ACW, which abdicates all responsibility for setting substantive qualifications for membership to State and Territory Units. Clause 4 of ACW's Constitution provides:

Each and every member of a State or Territory Unit shall be a member of Australian Church Women.

This is a procedural qualification only. State or Territory membership is both sufficient and necessary for ACW membership, with only life membership being a possible but improbable exception. So long as a person is a member of a State or Territory Unit, that person is thereby a member of ACW. In addition, the total ACW membership comprises only State and Territory members. The ACW Constitution sets no other qualification, not even that the person be a woman.

The only possible exception to this procedural qualification lies in life membership. Clause 4.1 of the Constitution states that there can only be one national life member from each State or Territory. For a person to be a life member, there must be a nomination by the relevant State or Territory Unit and an appointment by the National Conference, presumably when the Conference is satisfied that the life member is a woman who has made 'a long term significant contribution to Australian Church Women at the national level'. There is no *express* provision in clause 4.1 that a life member be a member of the relevant State or Territory Unit and, thereby, of ACW. That raises the *possibility* that a life member need not be a member of a State or Territory Unit beforehand, but it is only the slimmest possibility. It is more likely that, considering clause 4 as a whole, there is a necessary inference that a life member be a member of a State or Territory Unit. As a practical matter, it is unlikely that a nomination would be made or that a woman could have made a significant contribution to ACW without being a member of a State or Territory Unit beforehand.

Thus, in all respects clause 4 relegates any qualifications for membership based on belief or denominational adherence to State and Territory Units, and ACW is bound by the separate qualifications in that respect made in the constitutions of the State and Territory Units. The power to decide whether, eg, a Witness or Latter Day Saint can be a member therefore rests with each of those Units. Consequently, the question must be referred to each of the State and Territory Units, to be answered in accordance with their separate constitutions.

Revised membership qualifications (brief comments only). If ACW is concerned *not* to have Witnesses or Latter Day Saints as members, then the best means of ensuring

this is to have unambiguous membership qualifications to that effect included in State and Territory Unit constitutions or, indeed, in the ACW constitution itself. In the case of the State or Territory Unit constitutions, this may require a constitutional amendment to the membership clauses. In the case of ACW, there would certainly have to be a complete revision and amendment of clause 4. The most certain approach to clauses like these is to limit membership to women who are members or adherents of denominations listed in a schedule to the constitution, and simply not include the Jehovah's Witnesses or the Church of Jesus Christ Latter Day Saints in that schedule. Often, para-church organisations limit membership of the organisation to 'members of a Christian church'. This terminology is desperately ambiguous, and could - *according to the law* - encompass groups like the Witnesses and Latter Day Saints. It should be avoided at all costs.

Anti-discrimination laws (brief comments only). The recommended clause is undoubtedly lawful. There should be no concern that a clause limiting membership to women of listed denominations is in breach of anti-discrimination laws. First of all, there are no federal religious discrimination laws applicable throughout Australia, although the Human Rights and Equal Opportunity Commission has recently recommended that there be so. Secondly, there are no religious discrimination laws in New South Wales, South Australia and Tasmania. In those States, it is lawful to discriminate on the ground of religion (although racial discrimination laws provide some protection to ethno-religious groups). Thirdly, it is generally unlawful in the Australian Capital Territory, the Northern Territory, Queensland, Victoria and Western Australia to discriminate on the ground of religion in the provision of goods and services, employment, education, health and welfare etc. These laws do not apply to membership of private organisations, and in areas of doubt actually give express exemption to religious organisations as a recognition of their rights to discriminate. That is, religious organisations have the right to exclude from membership those of different beliefs in order to maintain their particular religious identities.
