MINUTES of MEETING of ACW NATIONAL EXECUTIVE held at  
9.30 am on 30th OCTOBER 1989 at UCA CONFERENCE ROOMS, SYDNEY.

PRESENT: Mrs. M. McCann (President), Mrs. H. Richardson, Mrs. M. Burtenshaw,  
Mrs. G. West, Mrs. Y. Davis, Mrs. L. King, Mrs. B. McLaughlin,  
Mrs. E. Walker, Mrs. M. Baker, Brigadier M. Ward.

WELCOME: The President welcomed Mrs. Marjory Baker, co-opted member to the  
Executive and presented her with her Badge; Mrs. Lucelle King was  
also presented with her Badge as W.K.S. Convenor.

MINUTES: The Minutes of Meeting on 21st September 1989 as circulated were  
taken as read and confirmed on the motion of Brigadier Ward and  
Mrs. West.

BUSINESS ARISING FROM MINUTES:

1991 NATIONAL CONFERENCE:

The only two of the suggested Venues which could accommodate our  
required number are the Salvation Army Conference Centre, Collaroy  
and Caritas Christi at Wahroonga.

After discussion, it was moved by Mrs. McLaughlin, seconded Mrs.  
Davis, that we confirm our tentative booking of the Salvation Army  
Centre at Collaroy.

A Conference Planning Sub-Committee was formed to meet following the  
State Unit Council Meeting on November 20th to explore ideas and bring  
a draft plan to the meeting on December 4th; this committee to be  
Mrs. McCann, Mrs. Richardson, Mrs. King and Mrs. Davis.

Mrs. West suggested that when planning the programme, some breaks or  
spare time be included, early in the week, so that retiring and new  
convenors would have time to get together regarding their own areas  
of responsibility.

ACW BADGES:

Mrs. McCann reported that other organisations she had investigated  
use "President", "Secretary" etc. when holding that office for the  
National body, and that the name of the State e.g. "N.S.W. President"  
was used for State office-bearers.

It was moved by Mrs. Davis, seconded Mrs. Burtenshaw, that all the  
National badges be checked and altered to included the appropriate  
superscriptions.

Mrs. King mentioned that she was given a number of ACWC Badges, some  
on pin and some on chains, to bring back from Perth. It was agreed  
that these be offered for sale at State Unit meetings; also some  
F.L.C. notelets passed on from Perth.

W.K.S. TRUSTEES ALLOCATIONS:

It was agreed that the appropriate amount be paid by the Treasurer  
at the meeting of the National Executive with Mrs. Dorothy Haensel  
on Monday November 6th.

REPORTS: W.K.S. CONVENOR - Mrs. Lucelle King:

Letter from proposed 1990 Scholar Doreen Tie Chin Bing of Kuching, Sarawak, Malaysia, advising that she will be doing a Child Care Course in U.K. until July 1990; would we agree to defer her Scholarship until then?

Possible responses: To advise that her entitlement would be invalid as she has received another scholarship; to agree to continue her entitlement but reduce it to cover second half of 1990 only, and seek a possible short course in Special Education for Mentally-Retarded Children which she could do, in Sydney.

It was moved Mrs. McLaughlin, seconded Mrs. Davis, that we continue with Doreen as our Scholar for 1990 but curtail the course to second half of the year and that we make enquiries re possible short courses.

Letter from a gentleman living in W.A. requesting that his native country, Nagaland, be included among countries to which W.K.S. Application Forms are sent. It was agreed that as Nagaland is a state in northern India, this matter would not have to wait for next National Conference to be resolved. Mrs. King commented that as 1990 Scholar will be from Malaysia, now included in Area 1, the Scholar for following year should be chosen from Area 2. It was agreed that Mrs. King follow this up, ascertaining where in India the Applications go to, as the Churches of North India and South India are entirely separate.

It was moved by Mrs. King seconded Mrs. McLaughlin that it shall be

recommended to 1991 National Conference that Application Forms should include a clause to the effect that if the applicant has accepted any other international scholarship within previous or following two years she shall not be eligible.

It was agreed that this should be continued by National Executive, independent of what State Units do, as part of our on-going interest and commitment to them.

Mrs. King requested that an up-to-date list of addresses be obtained.

F.L.C. CONVENOR - Mrs. Glad West:

There is need to obtain a supply of ACW Spoons as she has received request from A.C.T. Unit; Mrs. West is to contact Perfection Plate at Revesby.

PUBLICATIONS - Mrs. Mavis Burtenshaw:

Members present congratulated Mavis on her first issue of ACW News. She advised that 600 had been printed, with the help of some keen voluntary helpers from her home area; extra copies available if wanted. Mrs. Burtenshaw mentioned that Margaret Knauerhause has received a prize of \$100 for a Hymn Writing Competition run by the Uniting Church Musical Society; she has received a copy of another beautiful poem written by Margaret, which she hopes to include in a future ACW News.

SPECIAL DAYS - Mrs. Yvonne Davis:

FELLOWSHIP DAY 1990. Mrs. Davis advised that Draft Service has not yet been received from Brisbane. When to hand, she will send copies to Mrs. McCann, Mrs. Richardson and to Deaconess Andrews, to look over; these to be returned to her if possible at meeting on Monday November 4th. It was moved Mrs. Davis seconded Mrs. West that the above three shall be a small sub-committee for this purpose.

GENERAL BUSINESS:

ECUMENICAL MATTERS:

Mrs. McCann spoke of the 'Decade of Churches in Solidarity with Women' She asked that we obtain a copy of the Resource Booklets with a view to recommending to our State Units and their Branches to participate in the Discussion Groups that are being arranged by the World Council of Churches about this subject.

Mrs. McCann mentioned that next year our Government is to allow 60 "women at risk" from a number of different countries into Australia; they will be seeking people, families, churches and community groups to befriend them.
