We have a Baptist President this year 1963/4 & the Federal Board of the Baptist Women's League were not in favour, but the Baptists here have agreed to abide by the majority decision.

REPORT of progress made in respect to A.C.W.
by the Women's United Church Association of Sth. Aus.

Ever since the visit of Mrs. Mabel Wyllie to Adelaide in May, 1963, there has been a constant and growing interest evinced by many delegates to W.U.C.A. in the Australian Church Women movement.

There has also been a certain amount of opposition and when in September, 1963, a vote was taken as to whether we would be willing to act as the liaison body for the State with the Interim Committee of Australian Church Women, six affiliated bodies voted in favour, two against, and two refrained from voting. In March 1964, the Unitarian Women's League withdrew from W.U.C.A. because of our connection with the A.C.C. and in October, 1964, the Baptist Women's League withdrew for the same reason. However, the door is not completely closed in respect to the latter, and we await word from them concerning our proposal that they continue their association with us but do not affiliate.

On top of this there has also been a noticeable lack of enthusiasm on the part of delegates or associates who are active in the Women's World Day of Prayer Committee.

Despite such opposition it would seem that definite progress has been made over the past year, and the interest is certainly growing.

In May the two delegates who attended the Sydney Consultation, namely Mrs. E. Fitman and Mrs. E. Playford, together with Mrs. S. Haynes, ran a Conference Day on the theme "Australian Church Women". This proved to be so successful that time would not permit the completion in one day and we had another session in June. Both days were well attended and we felt that we were at last beginning to move.

In July our annual "Musical At Home" was held in the Adelaide Town Hall and through lack of a sponsor for the programme printing we were able to have the programme printed at our own expense and use the back page to print the aims of the Australian Church Women. This brought A.C.W. to the notice of the more than 600 present.

A number of women felt that a redrafting of our Constitution was long overdue and this was done and presented at the business meeting after the Annual Meeting in October. Delegates had had time to read and digest this draft before the meeting and it was obvious by the prolonged but worthwhile discussion of same that many had given a great deal of thought to the draft. It comes up again in March and we hope that this draft will prove to be the final one.

We did not observe "World Community Day" in October, but went ahead with our plans to hold our usual Advent Service on December 11th. We used the theme "Christians and World Peace" and adapted the service to "Advent", the collection being for the Christmas Bowl Appeal.

It was our desire that this Advent Service should express the part A.C.W. is to play within the Department of Co-operation of Men and Women in Church, Family & Society. To that end, two men and two women took part in the service; the organist was a man and the soloist a woman, and a Youth Choir comprising boys and girls from Secondary Schools and Church Schools - over 60 strong - led the singing.

The Lord and Lady Mayoress, Mrs & Mrs. J.C. Irwin, the Town Clerk and Mrs. Veale and other City Councillors attended and expressed appreciation for the beauty of the service and its message.

An all-out effort was made by the executive and delegates to interest as wide a cross-section of the community as possible, and although the attendance was far below our expectations (350 or more, comparing favourably with the 70 or so of last year) it was a great improvement on previous years. The collection amounted to £54. (£11 in 1963).

We have been happy to receive the utmost co-operation and helpful advice from the Secretary of the S.A. Council of Churches, the Rev. Alan Gray, who at all times has seen that news of A.C.W. activity is publicised. Since August the W.U.C.A. has had the privilege of attending the monthly Council of Churches meetings, and our representative has been encouraged to speak. Notice of our Advent Service was included in the World Council of Churches bi-monthly Newsletter which goes out to more than 700.

Although the special days of Fellowship and World Community Day were not observed in 1964, it is planned to hold both this year, in addition to our usual "At Home" and Advent Service.

Already there is much interest in the Winifred Kiek Scholarship scheme, and Miss Molly Trait, Columnist of the "Advertiser" wrote an article for us just prior to the Advent Service, and it is enclosed for the Committees perusal.

Concerning the Scholarship, however, it is recommended that A.C.W. collect sufficient money in the Trust Account before the Scholarship is launched and someone invited to come to Australia, thus assuring its continuance.

One fund-raising function was held by Mrs. Playford - a Floral Art night - and the amount of £3 is being held by our treasurer, and will be forwarded shortly.

There is little to report on the Fellowship of the Least Coin except to say that no real attempt has been made by us this past year to promote it. This we hope to do early in the year. The Y.W.C.A. were most interested and have taken more than 100 leaflets to distribute to their members.

It is planned that each delegate take a number of leaflets and that each denomination be responsible for the distribution of same and the collecting of the money which will be dedicated at a time to be arranged - probably at World Community Day each year.

Our President, Mrs. E. S. Playford, is also on the Executive of P.W.M.U. in this state and travels in the country with executive members. She takes every opportunity to spread the news of A.C.W., its aims and objects, including the Fellowship of the Least Coin. All delegates have been asked to do likewise whenever the opportunity arises.

Early May or early June would be the best time for "Fellowship Day" and October seems suitable for "World Community Day".

We may not seem to have progressed very far in the past year, but I am confident that what we have accomplished has indeed been a solid foundation for a future active body of women who will find themselves introduced to ecumenical experiences hitherto unknown.

It was a pleasure to have Mrs. Playford and Mrs. Pitman with us for the Consultation in March. They made a very valuable contribution to our discussions.

Dear Mrs. Playford,

Thank you for your letter. I am indeed sad to hear of the decision of the Baptist women to resign from the Women's United Church Association. This happened in Queensland too, but I felt this was before they were informed of the situation.

In the first place, I think it is important to make it clear that each State Council will continue to operate as it has always done in the past, and Australian Church Women, is simply the co-ordinating body of the State Councils - a move which became very necessary in view of the great need for a closer co-operation and understanding of other nations especially in South East Asia. It is hoped of course, too, that through this co-operation of the States, the State Councils will be greatly stimulated by their sharing of experiences, and the international contacts which Australian Church Women will provide.

The Baptist women had the same problem here. Their Union is not affiliated with the Australian Council of Churches, but the women of the Baptist Fellowship have been most active as members of the N.S.W. Women's Inter Church Council, and still are. At the moment our Recording Secretary and Treasurer are members of the Baptist Women's Fellowship. The decision reached by the Baptist Women's Fellowship of N.S.W. was that they should continue as members of the Women's Inter Church Council, but they would not vote on any Australian Church Women matters which come up in our State Council.

This arrangement is working most satisfactorily to all concerned. The Baptist women are still a very important and greatly appreciated part of our Women's Inter Church Council.

You will in due course be hearing from Mrs. Thomson, our secretary, but unofficially the W.V.C.A met last Friday & Mrs. Wells & I were able to give our reports which were well received. Although earlier we had thought to observe Fellowship Day in May as has been our custom in the past (except that it was known as Conference Day - 'Fellowship' is much less frightening than 'Conference'!!) we have now decided on July 23rd as suggested in Sydney, this partly because the studios might not be available in May & partly because our annual "musical 'At Home'" on 7th July will provide a wonderful opportunity for publicity & warm exhortations among friends to attend Fellowship Day!

But it is in connection with the studios that I am writing. I thought it might be of interest to you to know that the Federation of Methodist Women of S. A. whom I represent on W.V.C.A with Mrs. Arnold Hunt - is preparing a study on South East Asia also. We are introducing a new pattern of work this year which we hope will be of more benefit to meth. women throughout the state. A live-in conference is being arranged to meet at Murrumbidgee 21st - 23rd June. The program for the 22nd starts with

devotions & discussion on a bible theme to be led by Dr Ruth Gernand. There follows a session on South East Asia - addressed by two speakers, Dr. H. Perry, head of Hol. Teacher's College & Mr. Lawton of the Adult Education Dept. of Ad. University. Practical work-shops are planned for the afternoon. A committee led by Mrs. Hunt, is preparing this study, including the provision of booklets for the use of delegates on their return to their respective home fronts, to assist them in getting the message across there. This work is fairly well in hand I understand, (I am not on this committee), & not knowing how the A.C.W. plans ^{are} progressing, thought it worthwhile to tell you of it. I have Mrs. Hunt's full knowledge & approval in this & we wondered about the possibility of a mutual exchange of information perhaps, or even if necessary or thought desirable A.C.W. might like to use the material as prepared here.

If the National Com. of A.C.W. cares to follow up this suggestion Mrs. Hunt's address is 10 Wesley College, 20 King William Road, Mayville. S.A.

of
THE WOMEN'S UNITED CHURCH ASSOCIATION OF SOUTH AUSTRALIA
.....

1. NAME Women's United Church Association of South Australia.
2. AIM To unite Church women in their allegiance to their Lord and Saviour Jesus Christ.
To promote co-operation of men and women in the "Church, Family and Society".
To help Christian women to take a more effective place in the total life and mission of the Church.
To provide opportunities for Christian women of different Churches to worship, study and serve together and to encourage fellowship and service across national boundaries.
3. RELATIONSHIP The Association shall act as the State Unit of Australian Church Women.
4. MEMBERSHIP Membership shall be open to all women in each denomination of the Christian Church and to members of inter-denominational bodies such as the Y.W.C.A.
5. OFFICERS The Officers shall be a President and two Vice-Presidents (who shall be the immediate past President and the President-elect), Secretary, Assistant Secretary and Treasurer.
6. EXECUTIVE The Executive Committee shall consist of the Officers and shall have power to act upon matters requiring attention between meetings of the Association.
7. COUNCIL The business of the Association shall be conducted by a Council which shall consist of the Officers and six representatives appointed by each denomination of inter-denominational group of the Christian Church.
8. MEETINGS
 - i. Regular meetings of the Council shall be held.
 - ii. The Association shall meet at least 3 times during a year as arranged by the Council.
 - iii. An Annual Meeting shall be held in the month of October.
 - iv. Any member may attend any meeting of the Association but shall not vote unless a member of the Council.
9. ELECTIONS The President-elect shall be appointed annually by each denomination or interdenominational group with representatives on the Council, in rotation in the following order:- Methodist, Congregational, The Salvation Army, Church of England, Y.W.C.A., Churches of Christ and Presbyterian. (Other names to be added as they appoint representatives).

9. ELECTIONS
(contd)

- ii. The President shall hold office for one year.
- iii. The Secretary, Assistant Secretary and Treasurer shall be elected by ballot at the Annual Meeting of the Council, and shall be eligible for re-election provided that no person who has held the same office for 5 consecutive years shall be re-elected to that office for the ensuing term.
- iv. The following representatives shall be appointed each year by the Council:-
 - (a) 2 representatives to the National Committee of Australian Church Women.
 - (b) 2 representatives and 2 proxies to the National Council of Women (S.A. branch).
 - (c) 1 representative to The South Australian Committee of the Women's World Day of Prayer.
 - (d) 1 consultant to the South Australian Council of Churches.

10. FINANCE

- i. An Annual subscription of 5/- shall be paid for each representative appointed to the Council by a denomination or inter-denominational group of the Christian Church.
- ii. Personal members shall also pay an annual subscription of 5/- to a non-denominational cause, as decided by the Council.
- iii. Proceeds from the Annual Social Function shall be given by the Council.
- iv. In its capacity as State Unit of Australian Church Women the Association shall meet its obligations.

11. ALTERATION
TO THE
CONSTITUTION.

This Constitution may be altered or amended at any Annual Meeting of the Association upon the affirmative vote of two-thirds of those voting. Notice of the substance of the proposed alteration or amendment shall be given in writing to the Secretary at least three months before the Annual Meeting, and shall forthwith be communicated to the members of the Council.

We were most interested in your comments concerning World Community Day, and think the sending of a copy of the service to all Church Schools was a very good idea.



Thank you so much for the interim letter with a copy of Fellowship Day material. Another copy arrived with the minutes of last Working Com. meeting. The minutes & my letter to you, crossed in the mail.

I have been concerned too about the difficulty of effectively getting through to the denominations as a whole. W.U.C.A.'s practice is for one of the six delegates from each church to act as a publicity officer or liaison between us & her denomination. This is only partially successful. For instance the Federation of Methodist Women meet as an executive & as a member of executive I bring whatever arises to that meeting. The presidents of the three main groups within the Federation are automatically members

too & one would hope that they could be relied on to take information back to their groups. But understandably their own meetings - W.A.O.M., Women's Home Miss. Soc. & the Fellowships all have very full agendas ^{& sometimes for some reason or other they miss a meeting.} themselves. Meeting dates & other information is supplied to Federation exec. & printed in S.A. Methodist but so many do not take their church paper, & those who do do not always read it! So it seems that letters to the secretaries of all the women's groups within each denomination, costly in time & money, is the only sure way especially if the delegates to W.U.C.A. selected from the special interest groups, do not happen to be on the executive committee of their group! All very complicated! The Anglicans of course have no co-ordinating body & the Mother's Union, here, to A.B.M. & Church Miss. Society must necessarily be contacted separately. These groups within a denomination sometimes have difficulty in getting their quota of delegates ^{to W.U.C.A.} & ideally each should have its own information, publicity officer, but this added responsibility would ^{often} be sufficient to frighten a prospective new delegate out of agreeing to act in this capacity! Perhaps I've overdrawn the difficulties, but they are there & as we proceed in our new pattern of existence they will I hope gradually be eliminated! The meeting dates of various groups are on a separate sheet.

Mrs. Dick phoned me a few days ago. She was anxious to know whether I'd had any news concerning her proposed visit to Japan, feeling that time was so short now that she might not have time to make all the necessary preparations. I assured her that she would most certainly hear as soon any word from Japan arrived.

I have passed on your letter to Mrs. Ring so that she has the latest information to refer to. I hope I have not omitted anything.

Unfortunately the order of service prepared by Miss Jefferys for World Com. Day was considered too long - as it stood without a sermon it would take an hour! - And as she had intimated that she could not spare any more time on it, earlier, we considered the possibility of reducing it to the required length, but eventually came to the conclusion that by the very nature of it, this was not a satisfactory solution. Mr. Pemberton, sec. of S.A.C.C., in view of my ^{pending} absence offered to take over responsibility for inviting some one else to prepare something also, with the intention of submitting both to you

when ready for your decision in the matter.

Any further correspondence in the next few weeks, you have already promised to address to Mrs. Thomson.

Winifred Kiek Scholarship: It is now found that Miss Satyadevi Bali will not be able to avail herself of the scholarship. However, a full set of papers have been received from Miss Sabita Devi Swarup, an Indian young women of 23 years of age, who is attached to the Methodist Church at Lautoka, Fiji, where she is a Sunday School teacher and Scripture Instructor. The scholarship has been offered to Miss Swarup. Miss Swarup has basic typing and shorthand knowledge, and the recommendation accompanying her papers was that, through the scholarship, she gain business experience, which would be of great value to the work of the Church in Fiji. Miss Swarup is of Hindu parentage, and is herself an active Christian.

If we have definite word (and this we think should be likely) about her acceptance of the scholarship before the date of your 'Musical at Home' on 29th June, we will let you know.

Last year volunteers were sought in country areas who would be willing to receive literature and information supplied by Australian Church Women. As your name was one of those given me I am glad to have the enclosed material available to send you. It is our hope that you will find this useful in endeavouring to give expression to the basic unity of all Christians and in fostering friendship and understanding between women of different churches.

The 'Fellowship Day 1966' order of service is a very fine one. In the city we plan to use this on Friday, 22nd July, and women of the various denominations will read the scripture passages and meditations. Others will lead discussion groups and we look forward to rich and fruitful fellowship. These few copies are free but should you arrange a service in your area - and we hope you will - you will need more and they will cost \$2.25 per 100.

Perhaps you would be kind enough to share the reports with other churches in rotation.

The Winifred Kiek Scholarship has been awarded this

year to Miss Sabita Devi Swarup, and Indian Christian from Fiji. Miss Swarup will undertake a secretarial course and work in Church offices while in Australia.

Funds totalling \$50,000 given by Christian women around the world to the Fellowship of the Least Coin are being distributed to a wide variety of projects this year. The 25 projects being aided range from support of families of political prisoners in South Africa, to a farm project in Bolivia. In Asia the funds will support a Sunday School for the blind in Pakistan and subsidise the purchase of equipment for prison chaplains in New Zealand.

Collections from the Fellowship of the Least Coin are dedicated each year in October in South Australia at the World Community Day Service. Mrs. L. Thomson of 23 Willcox Avenue, Prospect, is the State liaison officer for the Fellowship of the Least Coin. You will be notified later of the date and place of World Community Day service.



Now that S.A.'s annual Musical At Home is in the past again for this year I must reply to the various matters mentioned in the Working Committee minutes received just prior to this function, and bring you up to date with general news.

Some alterations to the W. U. C. A. constitution are being considered. It is expected that the name will be changed to Women's Interchurch Council of S.A. at the annual meeting in Oct. No provision was made previously for the affiliation of country & suburban groups should any desire this.

This also is being suggested.

In the discussion regarding a travel fund at the April meeting representatives of two denominations stated that it had to be recognised that not all members of any denomination were vitally interested in inter-church work + that any suggestion of a levy on denominational groups would almost certainly be unwelcome to many - That in consideration of the proposal to become the state unit of A.C.W. three years ago they were told there would be no additional expense - Since when group affiliations have risen from \$1 to \$3, & contributions have been made, quite willingly, toward travel expenses to the Asian Church Wm's Conf. But further requests for annual travel expenses might not be favourably received. In S.A.'s present circumstances therefore the suggestion from the working committee would not be very effective. As I have already reported in an earlier letter our efforts in this direction are confined to having a trading table at our bi-monthly business meetings, & as I understand it, purely to help an S.A. delegate, but should an Australia wide travel pool come into existence, this

money would constitute our contribution I presume.

A program of proceedings at the 'At Home' is enclosed & you will note the publicity for Fellowships Day on the back of it. A number of inquiries were received for sample copies of the Order of Service. As we now expect to have Miss Busina at the central observance our own attendance will almost certainly be greater. Having supplied Pl. Raie with 40 O.S.'s & distributed the samples already mentioned, plus posting another doz. to various contacts in the country I am somewhat concerned to learn that the working committee had only 400 left on June 9th! I am wondering what the situation is now. - Whether it was possible to have more printed if needed - whether the 400 are now gone & no more available? The attendance here in the city last year was 90-100. It could be 150-200 this year - It is hard to judge - but I would have an easier mind if 50 more copies are available.

If the brochures on Miss Anna Busina are on hand would you kindly forward some immediately as a newsletter is being prepared which should go out this week (including Fellowships Day material!) I would be grateful if you would let me know

promptly if it is not available so that we do not delay the sending unnecessarily.

Regarding the Circle of Prayer booklet No. III our S. A. convenor of the S. of L. C. is writing, or has already written to Mrs. Strack. Would it be possible for this lady, Mrs. D. Thomson, 23 Wilcox Ave., Prospect, S. A. to receive copies of Working Com. minutes? She would be pleased to have them - to have information first hand to which she can refer.

The group discussions material taken from last Com. minutes was distributed at our meeting on 9th June to delegates of all affiliated bodies, so that after consideration at their meetings, comments & suggestions may be given at the Aug. meeting. Our meetings are bi-monthly on the same day as yours.

We are delighted at the prospect of having the scholarship holder in our midst for this year. Mrs. Harold Hunt was seeking information concerning the possibility of someone from Louisiana Christian Medical College, ^{Durham} applying for it. We have a number of copies of the details that appeared in earlier last Com. meeting minutes & I am sending her some of these but I wondered

whether further information could be supplied. Her address is Wesley College, 30 King William Rd., Wayville S. A.

I think that is all for this time.

ANNUAL REPORT 1966 - 1967

It is with pleasure that I present the 21st Annual Report of the Women's United Church Association.

Mrs. S.G. Haynes, a Congregationalist has been our President for the past year, Mrs. E.C. King a Methodist, immediate past president, and Mrs. V.F. Meyer an Anglican, President-elect. Other executive members were Mrs. J.R. Howie, Assistant Secretary, Mrs. M.G.R. Crosby, Treasurer, Mrs. D.D. Thomson, convener of the Fellowship of the Least Coin, Mrs. D.M. Maynard, Social Convenor and Mrs. A.R. Pitman, Secretary.

Three business meetings were held with an average attendance of 25 and together with the World Community Service, Fellowship Day and the Musical at Home, make a total of 6 meetings. In addition a special meeting was arranged in February so that the South Australian women might meet Mrs. Don Badger who attended the third Asian Women's Church Conference held in Japan in July, 1966.

The order of service for World Community Day 1966 was prepared in South Australia (full details were given in the previous Annual Report) and the service held Maughan Church on United Nations Day, 24th October, 7.45 p.m. Believing this to be an occasion that should be shared by men and women, the South Australian Council of Churches was invited to participate fully in the planning of it, Mr. Pemberton, Secretary of S.A.C.C. gave all the help he could for which we were most grateful. The attendance was somewhat better than at the lunch hour service the previous year and there were a few more men present. The service was lead by our President Mrs. Haynes. Questions relating to migrants, family life, and the community of nations were discussed by a panel of speakers and the offering amounted to \$30.00. The Fellowship of the Least Coin monies received at the service totalled \$182.00 and the state total for the year was \$247.00.

At the National Committee Meeting of Australian Churches our representatives were Mesdames. Haynes and Ray who reported at the April meeting that it was very worthwhile. The question of a travel fund for delegates to the Annual Meeting arose, and it was agreed to have a trading table at each meeting. Miss Sabita Swamp, the Winifred Kiek Scholar for 1966 was present at the National Committee Meeting but returned to Fiji immediately afterwards to take a position at the Ba Hospital, which had always previously been filled by an Australian.

The Musical at Home was again a very happy occasion. The Lady Mayoress (Mrs. Walter Bridgland) attended and graciously responded on behalf of the invited guests. Mr. Bruce Pearce of the British and Foreign Bible Society spoke of the work being done. We are indebted to Miss Nancy Thomas for arranging the delightful programme. The artists were Anne Adamek, Solo Harp and Accompanist, Margaret Cummins Soprano, and Jane Carter, Contralto who substituted for Shirley Alderton who was prevented from attending because of a family bereavement. The women of the Salvation Army are to be congratulated on the result of the trading table - \$64.48. Acheque

for \$180.00 will benefit the British and Foreign Bible Society.

Fellowship Day was celebrated in Scots Hall. The theme being "Let the Church be the Church in Daily Living" about 70 women attended from 10 different denominations and groups. The Rev. R.B. Leavin gave the address. After the service groups considered the prepared questions. The summing up was done by Mrs. H.G. Wells who was farewelled on her departure to Sydney. The offering amounted to \$27.52. Port Pirie also held a service this year. Offering \$8.15. The Hilltown Methodist Ladies Guild invited the denominations to an inter-Church Fellowship Day with guest speakers from W.U.C.A. Offering from this meeting for the Winifred Kiek Scholarship \$15.30. In trying to judge the value of Fellowship Day discussions it was suggested that more effective "fellowship" might be achieved in the suburban areas and it was resolved that the possibility of decentralised meetings be examined in 1968.

The W.U.C.A. had other speaking engagements at at the birthday meeting of the Coonalpyn Congregational Womens Fellowship when women of other denominations were also present. The offering on this occasion supported inter-church aid and Rosemary Taylor in mind. A.C.W. brochures were distributed at these country meetings.

At the first meeting of the year it was felt that the W.U.C.A. should keep in touch with Rosemary Taylor a young Roman Catholic, the only South Australian volunteer for inter-church aid learn work in Viet Nam. Mrs. Wells wrote asking for suggestions regarding some practical help. A panel was later despatched and greatly appreciated.

It was disappointing that the "live in" conference arranged on behalf of W.U.C.A. by the Christian Education Committee of the Churches of Christ Women's Conference Aid not eventuate because of insufficient registrations. However, those who did register enjoyed a dinner at Nunyara and heard Mrs. E.V. Laveton - just back from America - speak of her experiences. A representative of each denomination present then outlined the structures of their women's organisations and the scope of their activities. A W.U.C.A. Committee is now planning a day conference - (23/2/68 is the likely date) - when the work of women in South Australian Churches will be studied under such headings as "what is being done?" "what ought to be done?" and "how best can we serve?".

The Australian Church Women Working Committee has requested all states to examine the aims as set out in the constitution and to try to assess how successfully they are being fulfilled. It has also asked for suggestions.

The W.U.C.A. is delighted to have the full co-operation of the South Australian Council of Churches Secretary, Mr. Pemberton at all times and especially in the planning and publicity for the service on World Committee Day. Your Executive Committee plans to recommend to the working Committee.

Firstly, that consideration be given to the proposal that the A.C.W. invite the Australian Council of Churches to plan and put into effect together the future observance on an annual World Committee Day.

Secondly, that in any case, the words "Australian Church Women" should not be placed so prominently on the Order of Service if it is desired, the occasion be not restricted to women.

These suggestions are designed to implement the second aim .

In South Australia various suggestions were made regarding the third aim, to help Christian women to take a more effective place in the total life and mission of the Church. They included :-

1. Association with Australian Frontier and becoming familiar with its aims.
2. Association with Camera, an organisation promoting education on alcoholism.
3. Being better informed about inter-church aid, projects and others.

THE WINIFRED KIEK SCHOLARSHIP

Miss Anna Busina of Papua was appointed the Winifred Kiek Scholar for 1967.

Unfortunately, her coming to Australia was delayed for 6 months for health reasons. Soon after her arrival in July, the W.U.C.A. executive committee members and Mrs. Kiek were able to meet Anna at morning tea at the "Y" through the kind invitation of the Y.W.C.A. staff. She is a charming and intelligent young person. It was planned that she should attend the World Conference of the Y.W.C.A. in Melbourne and do a course of training in "Y" work in Adelaide, to equip her for service in the Y.W.C.A. at Port Moresby. We were very sad later to learn that for family reasons she had had to return home when her training had just begun.

WORLD COMMUNITY DAY 1967

The material for the service of worship and panel discussion to be held at Maughan Church, 24th October at 7.45 p.m. is very good indeed. The theme - "World Community through the United Nations". The Rev. Michael Sawyer is to be the presiding minister and the excellent panel is comprised of Dr. Martha Anderson, Prof. Graham Lawton and the Rev. Robert Haughton. Please promote this occasion to the best of your ability and pray that it may be a great inspiration to us all.

In conclusion I thank you all for your support and co-operation and ask that it be extended just as loyally to my successor.

MEET WOMEN'S INTER-CHURCH COUNCIL OF S.A.

This Interdenominational group began in 1936 as a result of the involvement by church women in the centenary celebrations, particularly flower day. It was first known as Women's United Church Association. (It is interesting to note that Women's World Day of Prayer began in S.A. in 1940.) Since its inception, this group has promoted 'thinking together' and 'raising money together'.

The Annual At Home is now a well known function when the money raised is used for some non-denominational charity.

We became the State unit of Australian Church Women in 1963.

The aims of A.C.W. are to:-

1. Unite Australian Church Women in their allegiance to their Lord and Saviour, Jesus Christ.
2. Promote co-operation of men and women in the church, family and society.
3. Help Christian women to take a more effective place in the total life and mission of the church.
4. Provide opportunities for Christian women of different churches to worship, study and serve together.
5. Encourage fellowship and service across national boundaries.

These aims are worked out through our two special days and our two projects. We promote and support Women's World Day of Prayer in March and in July we promote and celebrate Fellowship Day. On This day, we have an opportunity to think together of our responsibility in a particular area of involvement. The offering from this day supports the Winifred Kiek Scholarship.

The purpose of this scholarship is to give further training to a Christian woman who has already received her basic training. The holder spends part of the year in a training school or university, part in practical work and observation in church and community institutes, with opportunities given to meet church women's groups. The period of each scholarship is ten months. The scholarship is named after the Rev. Winifred Kiek B.A., B.D. who was ordained as a Congregational minister in Adelaide in 1927. She was a pioneer in two fields - as an ordained woman minister and in her work for the Australian Council of Churches concerning women in the churches.

In October, we promote and celebrate World Community Day. This is the day when we look at our responsibility in the world. In S.A., we are trying to promote this day in co-operation with men wherever possible. There is an offering for a particular area of need in the world. This is also the occasion when the Fellowship of the Least Coin money is received. The Fellowship of the Least Coin is a movement of prayer and concern for all women in God's world. As a token of her concern, each member of the Fellowship, in over fifty countries, gives the least coin in her country for projects in all six continents. Significantly, the idea of sharing 'The Widow's mite' was conceived in Asia by an Indian woman, Mrs. Shanti Solomon, who realised that rich and poor, illiterate and college graduates, all women have something to give each other.

In S.A., there are two affiliated groups, Goodwood and Colonel Light Gardens. The present members of W.I.C.C. (S.A.) are Methodist, Congregational, Salvation Army, Church of England, Y.W.C.A., Churches of Christ, Presbyterian and The Girls' Brigade.

We have representatives from the Baptist and Roman Catholic Women's groups and communicate with the Lutheran women.

Our executive members are pleased to address any group interested to know more of our work and further information, particularly about the Fellowship of the Least Coin, is available on enquiry.

The following is a report of our Conference at Nunyara, which our delegates mentioned at the recent conference.

The Barriers are down!

The temperature was 99.6 degrees, the humidity 60° when 56 women from ten denominations and the Y.W.C.A. met at Nunyara, Belair on February 23rd

The meeting organised by the Women's Inter-Church Council was especially for the Executive members of each Church women's organisation and the Y.W.C.A.; that they think together of mutual areas of concern and learn of United, and Co-operative work being done.

During the morning. 'What is being done?' and 'What ought to be done?' were the session titles. Australian Church Women, Women working in United Parishes, Co-operation at Elizabeth and Inter-Church groups, were the four illustrations of 'What is being done' These were ably presented by four women.

The conference split into 'areas' or 'districts' and 'brainstormed' on 'What ought to be done.'

After lunch a plenary session gathered the main talking points together. It was interesting to see the concern for lonely people especially in hospitals, both public and private. And more especially long-term patients in geriatrics and paraplegic wards. Also there was a real concern for those who are emotionally disturbed. The conference asked W.I.C.C. to make a survey of hospital visiting, that overlapping and omissions might be avoided.

Many spoke enthusiastically of co-operative work being done and were encouraged to strengthen this wherever possible. Women's World Day of Prayer was mentioned as one co-operative piece of work and the suggestion was made that such district groups be encouraged to promote Fellowship Day and World Community Day, so that women not only pray together, but study and serve together as well.

An interesting observation was that, women work together regardless of denomination in secular organisations such as school committees, Meals on Wheels and other service groups, but split up for Guild or Fellowship. Why not hold combined, district guilds?

experiences and reactions. I understand that they have made this known to Doreen Strack and now to Harvey Perkins.


Re a minute in the October 1967 minutes (8 Reports (I))

ANNUAL REPORT 1967-1968

Mrs. V.F. Meyer was nominated by the Anglican Church in S.A. as the President for 1968. She has proved a capable and charming president and has endeared herself to us all.

The president-elect was nominated by the Y.W.C.A. and is Mrs. R. Crosby. The Council consists of six representatives from each of six denominations and two inter-denominational groups. During the year the membership of the Girls Brigade was received. The Executive consists of the President, President-Elect, Immediate Past President (Mrs. S. Haynes), Secretary (Mrs. T.R. Howie), Assistant Secretary (Mrs. A.C. Smith), Treasurer (Mrs. M. Crosby), Convenor of Least Coin (Mrs. D.D. Thomson) and the Social Convenor (Mrs. D. Maynard). Both bodies have met five times during the year.

The annual celebrations of World Community Day, the "At Home" and "Fellowship Day" were arranged by sub-committees, leaving more time at Council for the receiving of reports from our representatives to Women's World Day of Prayer, the National Council of Women and the Association of Mental Health. We thank our representatives for their faithful attendance and interesting reporting.

Occasional reports were received from our delegates to Australian Church Women, our Fellowship of the Least Coin convenor and our consultant to the S.A. Council of Churches.

Women's World Day of Prayer (Our representative Mrs. S. Haynes)
It is our council's turn to nominate the President-Elect of this organisation and we are pleased that Mrs. R. Crosby has accepted.

National Council of Women (Our representatives Mesdames Stirling and Leaver)
This organisation reminded us that 1968 is the 20th anniversary of the declaration of Human Rights.

Following a report from the S.A. Mental Health representative, we wrote to the National Council of Women asking that an investigation be made into the conditions of the geriatric and juvenile cases at Glenside Hospital.

S.A. Mental Health Association (Our representative Mrs. Simpson)
Mrs. Simpson continually reminded us of the growing need for workers in this field, and of the plight of some patients in hospitals and hostels.

S.A.C.C. (Our consultant Mrs. R. Crosby)
We were informed of the W.C.C. Fourth Assembly at Uppsala and of the pre and post Uppsala conferences held at St. Peter's College.

Australian Church Women (Our delegates Mesdames R. Crosby and A. Smith)
An interesting report of the Annual meeting was presented to the April Council meeting. Unfortunately the late arrival of minutes from this organisation left us uninformed for most of the year. However, we were informed that Miss Jacki Kiri is the 1969 recipient of the W. Kiek Scholarship.

Fellowship of the Least Coin. Mrs. D.D. Thomson is our officer, and has faithfully fulfilled her responsibilities in this work. As the Fellowship becomes more widely known, so the number of members increases. The offering is presented at World Community Day.

World Community Day 1967 was celebrated in Maughan Church on United Nations Day and the Theme was 'Towards a World Community'. The presiding minister on this occasion was the Rev. M. Sawyer and the panel which discussed the given questions consisted of Dr. Martha Anderson, Professor Graham Lawton and the Rev. Robert Houghton. This is the only occasion to which we invite men. Their participation is appreciated.

The "At Home" was held at the Y.W.C.A. this year, which broke a tradition of many years, as the "At Home" had been previously held at the Adelaide Town Hall. Rising costs made it uneconomical to continue with this venue. A delightful programme of music provided by the young Adelaide artists Shirley Alderton, Anne Adamek, Shirley Anne Gale and Esme Smith, plus a challenging address by Dr. Tom Alan provided a balanced programme which was enjoyed by those present.

Fellowship Day. This day was celebrated in Scots Church Hall on Friday, July 19th when approximately 90 women heard the Rev. E. Hind address us on "All Things New", the theme of the World Council of Churches Fourth Assembly. Mr. Hind was very challenging and thought provoking: providing the necessary stimulus for the study groups which followed. This is the day on which we especially remember the Winifred Kiek Scholarship for which the offering is used.

Conference and Seminar. On February 23rd of this year the W.I.C.C. invited the executives of all Church Women's Organisations to meet at Nunyara. Approximately 70 attended to consider "What is being done? What ought to be done? How best can we serve?".

A very real concern for hospital visiting and the after-care of ex-mental patients was obviously the area for concern and the W.I.C.C. was asked to sponsor a Seminar on this subject. This Seminar was held at Nunyara on July 1st when 90 people attended from 9 denominations. The speakers were the Rev. F. Hansen, chaplain at the Queen Elizabeth Hospital, the Rev. Alan Farr, chaplain at the Glenside hospital, Mrs. F.L. Weiss, a prominent worker in hospital visiting with the Lutheran Church, and Dr. Gabrynowicz, Snr. Psychiatrist, S.A. Dept. of Mental Health, and Matron Rogers of Winchester Hospital.

Discussion took place in regional groups, North, South, East and West. The plenary session revealed that many felt the need of (a) co-ordinated visiting of hospitals (b) the need for training (c) a desire to serve. Following this, women from the Eastern group met at Parkin College, Kent Town on July 30th when Dr. Dibden of the S.A. Mental Health Association spoke on the need of a domiciliary care programme to be set up in S.A. An immediate response from the women encouraged Dr. Dibden who had been seeking volunteers to deliver clean linen to patients in their own homes.

The hospital visiting presently being done was noted and following the meeting letters were sent to all Church women's groups through their ministers informing them of the findings of the meeting, seeking their reaction and asking for their co-operation and offering a training service. A letter was also sent to the matrons of all hospitals in the area. A similar meeting was also held at Brougham Place Congregational Church Hall for the women of the northern suburbs on September 27th.

Dr. Dibden has offered to have a "pilot" training course conducted this year to be followed next year by training for all who are interested. The S.A. Council of Churches has been behind us in this work and offered the service of its office, for which we are grateful.

Treasurer. Our treasurer was granted leave of absence as she went to England as a delegate to the International Conference of Girls Brigade.

Trading Tables. A trading table, proceeds of which go to our travel fund, has been held at each meeting.

Constitution. A change in the constitution limiting all executive officers to a term of not more than five years has been made.

Some council members have been privileged to address Church Women's Groups. Such opportunities are rare and more would be welcomed.

The Secretary is grateful to Mr. G. Pemberton, Secretary of the S.A.C.C. for his support and enjoys the opportunity afforded her of working with him and thus being able to further the outreach of W.I.C.C.

Looking Forward. At the August meeting it was moved that plans be made to have Fellowship Day celebrated in a number of areas in 1969. Contacts have been made and plans are under way. The executive hopes to promote Fellowship of the Least Coin and to continue to foster the hospital visiting and thus fulfil our aims which are -

- To unite Church women in their allegiance to their Lord and Saviour, Jesus Christ.
- To promote co-operation of men and women in the Church, Family and Society.
- To help Christian women to take a more effective place in the total life and mission of the Church.
- To provide opportunities for Christian women of different churches to worship, study and serve together, and to encourage fellowship and service across national boundaries.

I must apologise for my tardiness in sending you the details of our suggested project for a Fellowship of the Least Coin Grant. I have been able to get some information about the Council of Aboriginal Women of S.A., and their establishment, at last, of their Aboriginals' Advice Bureau. Through their own efforts the Council had raised some hundreds of dollars towards the salary of a Social worker, when they were able to get a three year grant ~~for~~ Social worker's salary from a private firm in Adelaide. The S.A. Government, with its strings attached have made premises available and an office & club centre will be established there. This will provide a meeting place for aboriginals in the city of their own, which is independent of any Government control. Most of the Council's money has been taken up with buying furniture & other necessities and there are still several fairly large items which they need - a piano, a refrigerator, ^{staple} and a car!! (for the social worker). besides other electrical things such as radiators.

All the S.A. members understood that a minute had been passed that these would be made available along with material used by Deaconess Young. As we haven't the minutes we are unable to check on our memories, but the five of us felt that this had been passed. Therefore we are disappointed to read under 'Other Business' of the minutes dated April 17. that--It was decided that A.C.W. would not consider publishing a leaflet on this material but would be happy if the Com. on Co-operation went ahead with the original plan of using this material.

In view of this minute our Council moved (June 5th) that-- We propose to A.C.W. that all addresses and material used for devotions be included in the minutes of future National Committee meetings. That these minutes be made available at the earliest possible opportunity.

The annual musical "AT HOME" will be held this year in the Y.W.C.A. Hall, Pennington Terrace, North Adelaide on Wednesday, 8th July. Please make this occasion as widely known as possible and note that the time of the "AT HOME" is 10.30 a.m. Morning tea will be served from 10 a.m. and there will be the usual well stocked trading table which the Salvation Army run for us. Money raised by the sale of tickets and the trading table is given each year to a non-denominational charity. In this way, we align ourselves with the many splendid works done by the community for those who are less privileged. This year it is to provide a University hostel for girls in Port Moresby. Many of these girls come from a simple village life where they have been under a strong code of discipline and where they are often the chattel of men. It seems good therefore that they should have accommodation for themselves where they can live and study and begin to learn how to cope with what we call civilization. The appeal has been launched and is being supported by the National Council of Women, an organisation with which we are affiliated. The artists at the "At Home" will be June Sutton and Merle Alderton (duet), Dorothy Oldhan (piano), Joan Drew (soprano) and Kathleen Goldsworthy (accompanist). Mrs. Jane Nelson who has experience of the work of the University will speak.
