THE RECTOR'S LETTER

All Saints' Rectory,
24th February, 1952.

Dear People of All Saints',

It is a very good thing that city and suburban churches should have Harvest Festival Services. We are apt to think that the industrial and commercial activities in which we are engaged are the primary and basic elements in our country's life. We city-dwellers need to be reminded that we are dependent for our very existence on the toil of our fellows in the rural areas. But the townsman can, in turn, contribute to the life of the agriculturalist, and he does so by supplying him with machinery, services and amenities which lighten his toil. Because "we are members one of another" and each one lives on others, we must see to it that we perform our individual tasks, whatever they may be, so faithfully that we enrich the common life of all.

This year's Harvest Festival was as successful as the many that have preceded it: we are grateful to **ALL** whose hard work, loyal co-operation and generosity made it so. Particularly are we indebted to those who made the Church look very lovely, to the Choir members for their efficient work throughout the day, and to those who sent the various and useful gifts, which were as numerous as ever, and included a great many from the Kindergarten and Senior Sunday Schools offered at the Children's Festival Service. Altogether it was a day of real Thanksgiving and an acknowledgment that we all live on God—we live on His goodness and His faithfulness to His promises.

By the time you read this, Lent will have commenced. We hope you will take advantage of the many opportunities your Church provides for the proper observance of this solemn season and of Holy Week. By self-denial, prayer, sacraments, worship and study we are enabled to come nearer to God, and particularly during these 40 days are we called upon to be alert and watchful of the menace of so many things that leave God out of life. Read again the matchless passage in Deuteronomy, Chapter 30, Verses 19 and 20. Trying to be good by our own unaided effort is futile, and endeavouring to be a Christian in our own strength will never get us anywhere. We need the very definite conviction that God, the God of Jesus Christ, is **power** equally with love, and that He is active in the hearts of men wherever they will admit Him into their lives.

Lenten boxes and envelopes were issued in readiness for the commencement of Lent. As you are aware, all our Lenten offerings received in this way are devoted to the work of the Australian Board of Missions and the Church Missionary Society. Both Societies seek increased support to enable them to meet the tremendous challenges facing the Missionary Church (which means you and me) in these days of greatly increased costs. If you have not yet received your Lenten box or envelope, please ask for one when you come to church; or, if you cannot attend, ask your District Visitor to procure one for you.


The next issue of the "Chronicle" will be on Palm Sunday, April 6th. It is necessary, therefore, to advise you now, regarding Holy Week and Easter Services, details of which will be found on the inset.

Once again we ask that you will take your place on the side of those who, by word and deed, are endeavouring to preserve the most sacred day of the whole year—Good Friday—as a Holy Day and not a mere holiday. Your Church makes ample provision for all her people to spend this most sacred day quietly and thoughtfully. Because men use the Day on which our Lord was crucified on Calvary's Hill for us and for all men, as a day devoted to pleasure and material gain, with a total disregard of the meaning of Good Friday, we must continue to protest against anything and everything which mars the solemnity of the day we remember the Cross of Christ, where the love of God and the sin of man meet, and where the sin of man is vanquished by the love of God.

We congratulate the South Australian Chamber of Manufacturers, which has announced that for the first time in 40 years, the Royal Adelaide Exhibition will not open on Good Friday. The organisers have decided this because of Church protests and because "it is desired to give all possible support to the ideals expressed in the Call to the Nation."

If Adelaide can do it, why not Sydney?

In Memoriam

His Most Gracious Majesty King George vi

who passed away in his sleep, in the early hours of Wednesday,
February 6th, 1952.

*"Our Sovereign Lord, the years of your high labours
Have held scant measuring of sunlit days,
So for your splendid bearing in the shadows
Yours be the greater love, the greater praise."*

"O man greatly beloved . . . peace be unto thee".—Daniel X. 19.

Those who may happen to have a "Chronicle" for February, 1936, will notice that the above lines were used when announcing the death of King George the Fifth on January 20th, 1936. The words are equally applicable to his son, whose passing we mourn and whose memory we honour.

The writer was in Westminster Abbey which was crowded on September 23. It was the Sunday morning our beloved King was undergoing a serious operation, and his people felt the desire to pray for him. Canon Adam Fox, the preacher that morning, prefaced his address with a few appropriate words about the King, and asked that the National Anthem be sung as a prayer, with special remembrance that the words "send him victorious" referred not only to victory over his enemies, but to victory over illness and disease. That prayer was not answered in the way we wished, but it **was** answered in another way. God gave the King power to rise above physical disability and courage also (using Mr. Churchill's vivid words) to "walk with death, as if death were a companion—an acquaintance whom he recognised but did not fear. In the end death came as a friend and, after a happy day of sunshine and sport, after a 'good night' to those who loved him best, he fell asleep as every man or woman who strives to fear God and nothing else may hope to do. . . ."

The shock of our King's passing has been the greater, because he seemed to be making such good progress; and although he had to take care, he was able to go about once again. We had high hopes of his restoration, if not to complete health and strength, at least to some reasonable measure of health, whereby he might be enabled to carry on. We now realise, according to medical reports, that we could not have expected his life to be prolonged very many years. But we can at least be thankful that death did not come to him before he knew the full measure of his people's gratitude and affection. We may be thankful, too, that we have had such a King for the past fifteen years.

The secret of the power of his personality over his people was that they came to see in him just the sort of man each of them instinctively would be—simple, sincere, frank, a lover of home and of healthy sport, loyal to his friends, keeping a high standard of personal life and public duty, steadfast in service, and mindful of his God. Such a man his people understood. They saw in him the simple, sterling virtues which each of them knew to be right for himself. Beneath this personality, which gradually and surely became so greatly beloved, was a foundation which must be specially remembered. It was his religion. There are only two words needed to describe King George the Sixth's religion: it was simple; it was real; it was based on an abiding sense of his responsibility and his duty to God. It was a King of simple, untroubled faith who gave to his people in a memorable broadcast in 1939, the words of M. L. Haskins:

"I said to the man who stood at the gate of the year,
Give me a light that I may tread safely into the unknown.
And he replied: Go out into the darkness,
And put your hand into the hand of God;
That shall be to you better than light,
And safer than a known way."

So he has passed from us—this man greatly beloved. Our love and loyalty bid us not only to keep his memory within us, but also his example before us.

Our hearts go out at this time in deep, respectful sympathy to Her Majesty Queen Elizabeth; to Elizabeth, the Queen Mother; the Dowager Queen Mother; Princess Margaret; the Duke of Edinburgh, and all the Royal Family.

Especially do we remember the young Queen, upon whom has now fallen so great a burden of responsibility. She not only commands our allegiance; but she has the understanding, the affection and the prayers of countless multitudes of her subjects. May God guide her aright.

God save the Queen!


