 - **Vice Presidents (Lee Edwards/Marie Majoor)**
 - Lee had written as requested by National President to Dr Angela McCarthy and to the Anglican Archbishop of Perth. Email from Archbishop Herft's Secretary saying he is away and will respond on return. Dr McCarthy enthusiastically accepted our invitation subject to confirmation of her teaching programme for 2013.
 - Marie and Lee had worked on the updated Draft Conference program (see General Business).
 - Newsletter ("National News") to include information/greetings from National President, Donna [ACWC], Sonya Pell [YWF in May] and Margaret Lawton [about PNG]. Also 'news' about the Conference 2013, 'our' Hymn, and the proposed Wildflowers tours on offer.
 - **Treasurer (Leeola Loughnan)** *Circulated/attached.*
 - Acceptance of report moved Leeola Loughnan, seconded Marie Majoor.
 - Further discussion with the Australian Taxation Office (ATO) had resulted from the need to apply for a new ABN consequent on incorporation. This has now been issued (backdated to 3 March 2009) together with a Tax File Number. Leeola is registered as the Public Officer for dealings with the ATO. It was noted that this is an entirely separate issue from our need to have a Public Officer as an association incorporated in the ACT.
 - We now also need to re apply for endorsement as a *tax concession charity* or *income tax exempt fund*. Marie Majoor as Vice President advised that after discussion between herself, Laurel and Leeola she had spoken on several occasions to the ATO officer (based in Queensland) who deals with this area, and had received advice on how the form should be completed. At this stage it appears that we need to alter our status from charitable institution to income tax exempt fund. We are also required to identify the extent to

which our organisation pursues its purposes outside Australia, and the percentage of our expenses involved, and to provide detailed financial information on the most recent year for which financial statements are available. Marie and Leeola will confer further before submitting the form, and copies will be kept on file for future reference. Laurel thanked both for all their hard work on this issue.

- The 2011-2012 Financial Statement has been completed. Our Auditor Robert Burns is on holiday during July. It was therefore agreed that it was not feasible for audited statements to be presented to the August NE meeting (Guidelines p.3).

- The recent meetings in Bangkok were very productive. One priority item of discussion on the Gen Co agenda was the publication of an ACWC handbook/guidelines. I'm hoping that

our ACW members can help with this project. The aim is to have a booklet that clearly explains what the ACWC is and how it functions. To date, most members arrive at the ACWC meetings and General Assemblies with very little knowledge about the ACWC, and they have many questions that often remain unanswered when they depart. It would be extremely helpful if ACW members who have attended previous ACWC gatherings could let me know some of the things they would have appreciated knowing before they attended those events.

- The General Committee members were also very pleased with the outcome of the Young Women's Forum (YWF) that was held immediately prior to the Gen Co meeting.
- YWF—the young women who attended were excellent ambassadors for their countries and they each made valuable contributions to the proceedings. They were very articulate and passionate about their ministries and the role of women in the body of Christ. Sonya Pell, our Australian delegate, submitted a comprehensive report on the event and spoke of some of the personal highlights for her, and the motivation she received from the experience.
- Dr Fulata Lusungu Moyo, WCC programme executive for Women in Church and Society, was invited to attend the YWF in preparation for the WCC 10th Assembly and pre-Assembly that will be held next year in Busan, Korea, in October and November. The WCC theme is 'God of life – lead us to Justice and Peace', and Fulata told us that the YWF had inspired her for her preparations in presenting women's issues to the WCC and putting women in church and society back on the agenda.
